Welcome to spring! As the lake begins to reach full pool, the silted-in area closest to the beach begins to disappear. Please be cautious of this area. It is NOT recommended for skiing and tubing due to the shallow depth of the lake. We have reached out to two companies that do dredging and have awarded a contract to “map” the silt in this area. Aquatic Control, the company that sprayed the water willow, will be doing this mapping project, which will give us an exact understanding of the amount of silt that needs to be removed from the lake; this is an important first step in the dredging process. Aquatic Control will be waiting until the lake is at full pool to begin the mapping process. They will be using sonar and probing in a grid-like manner. If you should see them, please yield to their needs; give them plenty of room and please no wake.

A&S security will be doing our patrolling of the Lake Tishomingo area again this summer. Aaron, president of A&S, was asked, “What is the most common problem that you see here at the Lake?” Aaron responded that there are a lot of missing boat stickers. SO... This spring and summer we need your help to get your boat stickers up to date. We all enjoy this private lake development, but you would be surprised how many non-property owners try to use our lake. Your having the FREE Lake Tishomingo sticker on your boat will go a long way in helping our security team keep us private. **Please contact Justin Faulkerson at jfaulkerson80@yahoo.com. Justin will be happy to assist you with your boat sticker needs.**

A&S security has been instructed by the LTPOA board not to allow any boat, pontoon, kayak, raft, paddle boat, or stand-up paddle board to launch without a sticker. Crafts that are already on the lake without a sticker will be asked to remove the craft, and instructed on how to get a sticker. The LTPOA board is asking for your help in this matter and asking that you respect the security officers hired to help protect YOUR private lake.

LTPOA Meeting Minutes

Lake Tishomingo Property Owners Association

LTPOA Minutes February 9, 2021

Board members present: Steve Blaha, Mark Stubits, Jon Riche, Ken Stojeba, Mike Steeno.

There were 3 residents in attendance.

President Steve Blaha called the meeting to order at 7:10 pm.

President's Report

Steve asked the board members if they read the January minutes and if they had any additions, corrections or deletions. Ken made a motion to approve and dispense the reading of the minutes and it was seconded by Mark. MOTION PASSED.

Treasurer's Report

Jon read the financial report prepared by Shelby for February 2021. January had a cash inflow total of \$2,293.66 which included \$5.50 from interest, \$2,273.16 from 2020/2021 assessments and \$15 from gate cards.

The cash outflow for January totaled \$1,275.28 which included: Ameren (\$127.02), Charter (\$69.99), Happy Grass for 2 hours of salt spreading and cleanup of maintenance yard (\$460), Jon Riche for gate hardware (\$61.76), Phone.com (\$20.38) and Dormakaba for gate cards (\$536.13).

The checking account balance was \$215,898.77 as of 01/31/2021. Interest accrued in the Major Projects Fund account in the amount of \$13.93 resulting in a balance of \$164,035.80 as of 01/31/2021. Ken made a motion to approve the treasurer's report and it was seconded by Mike. MOTION PASSED.

Jon asked to give Shelby approval to pay February bills totaling \$3,608.67 which included: Holloran Construction for road fill work in December (\$1,630), Will Electronics for annual software maintenance plan (\$105), Charter (\$69.99), Phone.com (\$20.38), Ameren (\$120.11), Happy Grass for 11 hours of salt spreading, fueling and washing the salt truck and south side culvert work (\$1,130), Nathan Reed for a culvert pipe he purchased to make a repair on community property (\$469.19), and the Brown and James Law Firm for legal work (\$64). Ken made a motion to approve the bills and it was seconded by Mike. MOTION PASSED.

Maintenance

During the snow in January and February, the salt spreader had a malfunction. This issue slowed down the salting of the roads. Mark worked several hours on the roads, salting and spreading late at night. After the winter weather subsides, Ken will take the plow truck back to Snow Pro to have the spreader looked over. The spreader is still under warranty. We thank Mark for all his tireless work on the roads.

IV. BOATS - All boaters must be in compliance with Missouri State Rules and Regulations 1. The maximum boat length allowed is seventeen (17) feet excluding pontoon boats.

2. No boat shall be overloaded beyond the OBC rated capacity or have a motor that exceeds the OBC maximum rating.

Old Business

Steve met with a rep from Superior Seawalls to look at the lake and discuss our need to dredge. Superior also does sediment mapping and will be getting us an updated bid for this service. The board has another bid from Aquatic Control for mapping as well, and we hope to move forward with this issue soon. The mapping is crucial in order to obtain multiple bids for the dredge project.

New Business

Ken discussed the need for late fees on unpaid assessments. Ken drafted a letter which the board would send to residents informing them of the situation and an upcoming vote on the issue. His proposal would create a late fee each month until January 1 (each year), at which point all unpaid dues would be turned over to our attorney. The board was in general agreement to put this issue to lake vote. It was agreed to work on verbiage, late fee amounts, dates and other details.

The LTPOA is looking for a new Election Commissioner. Emmy Riche has volunteered as commissioner over the past 3 years. This position typically involves volunteer work around the time of the annual meeting in June. Emmy would be happy to answer questions if anyone is interested. Please contact any board member to volunteer.

Adjourn

Jon made a motion to adjourn and it was seconded by Mark. MOTION PASSED. Meeting adjourned at 8:36 pm

LTPOA Minutes March 9, 2021

Board members present: Steve Blaha, Shelby Reneski, Mark Stubits, Jon Riche, Ken Stojeba, Mike Steeno, Doug Leeker.

There were 6 residents in attendance.

President Steve Blaha called the meeting to order at 7:02 pm.

President's Report

Steve asked the board members if they read the February minutes and if they had any additions, corrections or deletions. Mark made a motion to approve and dispense the reading of the minutes and it was seconded by Doug. MOTION PASSED.

Treasurer's Report

Shelby read the financial report for March 2021. February had a cash inflow total of \$1,604.96 which included \$4.96 from interest and \$1,600 from 2020/2021 assessments.

3. No hydroplanes, jet skis, inboard motor, or air boats (swamp buggies) are allowed. All outboard motors must be propelled by a marine propeller, NO jet drives are allowed.

The cash outflow for February totaled \$3,608.67 which included: Holloran Construction for road fill work in December (\$1,630), Will Electronics for annual software maintenance plan (\$105), Charter (\$69.99), Phone.com (\$20.38), Ameren (\$120.11), Happy Grass for 11 hours of salt spreading, fueling and washing the salt truck and south side culvert work (\$1,130), Nathan Reed for a culvert pipe he purchased to make a repair on community property (\$469.19), and the Brown and James Law Firm for legal work (\$64).

The checking account balance was \$213,895.06 as of 02/28/2021. Interest accrued in the Major Projects Fund account in the amount of \$12.58 resulting in a balance of \$164,048.31 as of 02/28/2021. Ken made a motion to approve the treasurer's report and it was seconded by Jon. MOTION PASSED.

Shelby asked for approval to pay March bills totaling \$2,525.57 which included: Colburn Consulting for 6 months of site hosting (\$59.70), Wegmann, Eden for legal work (\$168), Ameren (\$130.85), Charter (\$69.99), Phone.com (\$20.38), Happy Grass for 50 hours of salt spreading and plowing, fuel, 2 hours for plow truck cleaning, and 7 hours to remove barrier poles (\$2,076.65). Ken made a motion to approve the bills and it was seconded by Jon. MOTION PASSED.

Building

Doug reported on an application from the McKinnons for a concrete path on O8. Jon made a motion to approve the sidewalk and it was seconded by Shelby.

Applications previously approved between meetings included:

- Lippet, K7-8, Construct a new patio roof.
- Hueseman, O7, Install a new boat lift.
- Richars, D17-19, Replace dock to existing size.

Maintenance

The problem with the salt spreader turned out to be the salt getting frozen and stuck in the spreader due to the extremely cold temperatures. The spreader will still be taken in to get checked out under warranty.

The plow truck has a hydraulic leak and will be taken in as well.

Ken asked about selling the forks for the bobcat because they are never used. Ken made a motion to sell them and it was seconded by Jon. MOTION PASSED.

An attempt is being made to swap the bucket on the bobcat. The toothed bucket would help scoop and break up the salt pile. Mark has spoken with someone who can do the work and will get back to the board with pricing. Ken made a motion to have the bucket swapped and it was seconded by Jon. MOTION PASSED.

Old Business

The board discussed instituting late fees for unpaid assessments. Mike looked into this issue and discussed the matter with our attorney.

The lake's attorney is currently involved in a case where a similar community instituted fines and late fees. Given the pending nature of this lawsuit, Mike's recommendation was to hold off on having a lake vote on this issue. A compromise of coming up with a structured schedule was discussed in regards to collecting the assessments. Details were discussed such as dates, notification from the board, letters from the attorney, liens filed and finally filing suit against those who have not paid. Jon volunteered to work on a schedule for approval at the next meeting. [See the Assessment Enforcement Schedule, below.]

After receiving multiple bids to have silt mapping completed, the board elected to go with the bid from Aquatic Control. They were selected due to their competitive bid and their impartiality, because they do not dredge. Mike made a motion to accept the bid from Aquatic Control and it was seconded by Shelby. MOTION PASSED.

New Business

No new business.

Adjourn

Ken made a motion to adjourn and it was seconded by Shelby. MOTION PASSED. Meeting adjourned at 8:40 pm.



Assessment Enforcement Schedule

While most property owners pay their yearly assessments in a timely manner, there are always a few individuals who do not. The LTPOA has discussed several ways to encourage everyone to pay on time. After deliberating, we have decided to draft and adopt a schedule that we will adhere to on a yearly basis. The following assessment enforcement schedule was presented to the board at the April meeting and approved by all seven members. Effective this year, we will be adhering to this schedule to collect the assessments that are so vital to our community.

July 1 - Assessment notices are SENT.

August 1 - Assessments are DUE.

September 1 - Assessments are LATE.

September 1 - Reminder email to all property owners:

This message is being sent to all property owners.
Thank you if you have already paid your assessments.

This year's assessment notices were sent out on July 1st. Any assessments not received as of today are LATE. Assessments can be paid with no penalty, until October 1st. After this date, the LTPOA will refer all unpaid assessments to our attorney. The LTPOA has the right to recover attorney fees and legal fees incurred.

September 15 - Send reminder email to all property owners again.

October 1 - Letter from attorney stating that a lien will be filed if payment is not received within 30 days.

November 1 - Letter from attorney stating a lien was filed and the LTPOA will file suit if payment is not received within 60 days.

January 1 - File suit (180 days after notices go out).



Register Your Boat!

The board hired a new security company, A&S Security, at the beginning of last summer. Aaron, the owner of A&S Security, attended the January LTPOA board meeting to discuss the past summer season and offer some suggestions.

Aaron stated that the biggest recurring problem was the launching of boats without registration stickers. Usually, these boats belonged to property owners. However, often they didn't, and these people were turned away for trespassing.

Boats that belong to property owners but that do not have stickers make it difficult for our security company to do their job. We have asked A&S to continue stopping boats without proper registration and to turn away trespassers.

American Black Bears

American black bears are medium-sized, one of the largest and heaviest mammals in Missouri. At one time black bears were abundant in our state, but they had become rare by 1850 and were nearly eliminated by 1931. Reintroduction efforts in Arkansas have increased their numbers here. Most Missouri bears live south of Interstate 44, but wandering individuals, mostly subadult males, have been seen as far north as the Iowa line.

Wild black bears are secretive, shy and afraid of humans. They're not normally aggressive towards people. Bears are active spring through fall. In the winter they enter into a lighter state of sleep than hibernation, known as torpor, in hollow dead trees, rock crevices, caves, or in deep brush piles.

Black bear fur can appear in various shades of color, but is predominantly black in Missouri. As omnivores, they eat everything from grasses and berries to fish and small mammals. They are partial to blackberries in the spring and acorns in the fall.

Be Bear Aware

Understanding and appreciating black bears will help protect them, allowing admiration and respect from a safe distance and minimizing any potential conflicts.

Here are a few tips to keep in mind:

- Stay alert and avoid surprises while in the woods.
 - Make noise, travel in groups and keep dogs leashed. If you encounter a bear, raise your arms and back slowly away. Do not run or turn your back.
 - Keep clean campsites by storing food and toiletries in a vehicle trunk or up at least 10 feet high, strung between trees.
 - If you are lucky enough to see a bear, leave them alone and help keep them wild.
- Don't leave pet food sitting outside. Feed pets a portion they'll eat at each meal and remove the empty containers.

- Store garbage, recyclables, and compost inside a secure building or in a bear-proof container until the day of trash pick-up.
- Keep grills and smokers clean and store them inside.
- Use electric fencing to keep bears away from beehives, chicken coops, vegetable gardens, orchards, and other potential food sources.

A New Beginning: An Update to the Entrance

With all of the improvements property owners have been making to their lots and homes, the LTPOA Board thought an improvement to the signage and utility of the entrance was due. Over the April 17 weekend, the concept became reality thanks to Jon Riche with assistance from Doug Leeker, Steve Blaha, and Rich Hirsch.



In terms of signage, the text has been updated and made more concise. Inside the gate is the notice that all guests must be accompanied by a property owner. Trespassors will be prosecuted.

When approaching the ingate, drivers are instructed to stop and wait for the preceding vehicles to pass through the gate.



The new look is well planned and color coordinated. Black reflective covers have been provided for the gate arms and bollards.

Visitors are warned of the \$250 fine for causing damage to the gate equipment. The stop sign is prominent.



Side gates have been installed on both inbound and outbound lanes. These gates can be opened to permit the passage of very large vehicles while still discouraging the passage of unauthorized ATVs.

Maintaining our System

Water Resources Management (WRM), our sewer system operator, will be doing routine maintenance on our STEP tanks this spring, probably beginning in mid-May. This will include cleaning filters, checking control panels, and judging whether tanks need additional servicing.

- 2. From 7:00 p.m. until 10:00 a.m., all crafts shall be restricted to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal).
- 3. During ski hours all boats are to maintain a marine pattern of counterclockwise travel.
- 4. Zigzagging, facing toward the stern while operating boat, reckless speed, operating craft while intoxicated and any other form of careless or reckless operation is prohibited.
- 5. Minimum clearance of freeboard from gunwale to the surface of the water while operating shall be six (6) inches for any craft.
- 6. Every craft must be equipped with an approved type of life preserver for each person aboard.
- 7. Boats operating after dark must be properly lighted.
- 8. All boating must be at least 100 feet from shore.
- 9. Right-of-way shall be in the following order: sailboats, row boats, canoes, pontoons.
- 10. No boats are to enter swimming area under any circumstances.
- 11. Reduce speed of all craft while in coves or launch area to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal)
- 12. If you see or think that anyone is in distress, make effort to help and notify patrol boat.

- VIII. SKI AND SURFBOARD SAFETY 1. Skiing or surfboarding is permitted from 10:00 a.m. until 7:00 p.m. (prevailing time).
- 2. Skier must wear an approved lifesaving belt or jacket at all times.
- 3. Keep boat and skier 100 feet from shore while operating.
- 4. All boats when pulling skiers must either be equipped with a rearview mirror or have at least two occupants.
- 5. Travel counterclockwise at all times and circle counterclockwise when picking up a fallen skier.
- 6. Never drive boat so that skier is closer than 50 feet from any object.
- 7. Take signal from skier only and never sit on gunwale of boat.
- 8. Operators of boats pulling skiers must be at least sixteen (16) years of age.
- 9. Skiing from cove entrance is not permitted. Skiing should start and end up on the main body of the lake.

- IX. SCUBA DIVING 1. Any property owner or guest scuba diving must have card signifying accredited course in techniques of diving. Report to the patrol approximate area where you intend to dive from.
- 3. Display diver flag on float or boat and stay within 100 feet of same. Boats and skiers to keep 150 feet from flag. Remove flag after dive.
- 4. No scuba diving in ski lanes except when search and rescue diving is being conducted.
- 5. Fish and game Laws must be observed by divers.

- X. SWIMMING 1. All swimmers must stay within fifty (50) feet of the shoreline except as noted below.
- 2. Swimming from pontoon boats is permitted (for short periods of time) in the lane between swimming, 50 feet from shoreline, and the ski lanes, 100 feet from shoreline.

- XI. BUOYS No buoys/tethered objects may be used in Lake Tishomingo without LTPOA approval.



I. FISHING

1. Fishermen must be accompanied by a lot owner except by special arrangements made with the lake patrol.
2. Fish may be taken using a rod or pole. Only three rods or poles per person are allowed, and there is a three-hook limit on each rod or pole.
3. Trotlines and jugs are prohibited.
4. The maximum number/quantity of fish per take, creel, catch or possession shall be according to the Tishomingo Anglers Association's current recommendations in accordance with the continuing effort to improve and modify each species and their population. These regulations are formulated after consulting our local fisheries biologist.
