Invasive Bush Honevsuckle

As you may have read in our past Lakeside Gardeners columns in this newsletter, we are trying to manage the invasive plant species that are negatively impacting our community. One of these plants is the invasive Bush Honeysuckle, which is overcoming our precious roadways, pathways, uninhabited lots, and the land that surrounds our entrance roadway.

Late fall and winter are the ideal time to remove this plant permanently. Are you willing to volunteer an hour or two on a Saturday morning? We would be thrilled for you to join us on the second Saturday of each month, starting in November. Currently scheduled dates are 11/19 and 12/17. A Blast from the Past

I copied this recipe for 7-Layer Cookies from my mother's recipe box to start my own recipe collection when I got married. I have modified the recipe a bit over the years but I still bake these every Christmas!

7-Layer Cookies

Preheat oven to 350°. Spread in a 9x13" pan in the order given:

- 1 stick melted butter (can melt in pre-heating oven)
- 1 cup graham cracker crumbs (mix with melted butter and press into bottom of pan for crust)
- 1 cup (6 oz pkg) chocolate chips
- 1 cup (6 oz pkg) butterscotch chips
- 1 cup flaked coconut
- 1 can (Eagle Brand) sweetened condensed milk
- 1.5 cups chopped pecans

Bake 25-30 minutes. Cool. Cut into squares.

This was mostly weekend use & is probably for parties. Second and third most used entry codes (3.8 times per day) were issued to Ken Droege Jr and E. Richars. Both were likely due to parties also. Mr Droege also has a long lasting building project.

Gate Arm Break by FedEx truck

The gate arm was knocked off its mount on Thursday (7-28) at 16:17:04 by a FedEx "RAM" van tailgating thru the gate. Plate is: B37 PHD (Garden State). A property owner said his son witnessed the event and when the driver was confronted, the FedEx driver cussed him out.

Amazon's "Key for Business"

Amazon Key for Business was installed on July 7. The system is based on cell phone service & grants the delivery driver temporary access & opens the gate. We do not know if Amazon drivers are using this service. One driver we quizzed still relied on impatient drivers behind him to open the gate for him.

MyQ Website

LTPOA Board members and gate committee members now have access to the CAPXLV gate entry system through the MyQ website. This means they can view gate activity and videos of people trying to enter the subdivision.

Maintenance

- The rock beneath the fence along the entrance looks very nice!
- There is an outstanding recall on the truck that will be addressed.
- Still waiting on delivery of the new patrol boat further updates to come.
- Weed Control on the Lake Aquatic Solutions coming tomorrow or Friday to decide if any further treatments are needed. We are not seeing any further vegetation growth so we are speculating we will probably have another light treatment of copper sulphate to continue to clear up the murky water due to the planktonic algae bloom.
- Water testing the Mizzou team has been taking samples – no results available yet.
- Yellow lines will be added to the lake road in the areas around the turns. A date has not been set for this work yet.

- Shea boat dock project Owners indicated they would stake out where the boat dock would be moved in order to resolve the issue. They have not done this yet. Doug will contact them again to get an update and get a dock application filled out. Ken will take over pursuing with the owners while Doug is out on vacation for 2 months.
- Lake Restriction Renewal We are getting close to the required approval percentage! Please spread the word if you know anyone who has not signed yet to get their documents turned in. Deadline for approval is July 2023.
- Update on M-N cove (M42-M46) issue regarding restoration of community property: Matt Holloran has completed excavation of reconstruction and the property will be seeded and strawed. Jon and Mark will inspect the results.

New Business

- There is a long-standing question regarding ownership of dock A07. Thomas and Beverly Grimm have recently purchased the property previously owned by the Jost family which includes lot A07. They have been notified by another Tishomingo resident that dock A07 had been sold years ago to another property owner. Research of the records shows that dock A07 has always belonged to the Jost family. There is no record of this dock ever being sold. Also, Ken Jost has maintained dock A07 for years. To document: Lot A07 is the owner of dock A07, in this case the Grimm family.
- A resident is parking his boat at dock F37 which he
 does not own. He is also telling the actual owner of
 dock F37 that this dock is a community dock where
 anyone can park. There are no community docks on the
 lake.
 - Ken will write a letter to the resident that is parking his boat at the incorrect dock asking him to discontinue this practice.
 - Ken will send a letter to the actual owners of dock F37 to indicate they are sole owners of dock F37.
- James and Carolyn Condict Jr. H17 The H17 dock has been restored but a permit has not been submitted for the work done. A letter will be sent to request submission of a permit for the dock restoration.
- Thomas and Beverly Grimm 6770 S. Lakeshore Dr. The Contractor stored rock on South Lakeshore Drive in order to support work being done for the Grimm property. The location of the rock minimized

Note that approval from the board may also be pending approval from Jefferson County depending upon the nature of the work being done.
- Dale McKinnon made a request to construct a 48-inchhigh fence on his property. The Lake Tishomingo Restrictions state that a fence cannot be taller than 42 inches, therefore the request was denied.

Security

- The Green City Disposal truck knocked the gate down. Mark talked to the president of the company who apologized and indicated he would take care of any cost related to the repair. Rich Hirsch was satisfied with the apology and volunteered his time to fix the gate at a very minimal cost.
- Aaron gave a status update on the court case regarding the drunk driver who knocked down the gate last year and then attacked a Tishomingo guard (Eddie).
 - The accused was found guilty of property damage and DWI. He has been ordered to pay Lake Tishomingo \$500 in restitution for property damage plus is serving 5 years in jail for the DWI which is his fifth offense.
 - The assault charge has been dropped.

• When someone uses a remote transmitter to open the gate, there is usually no video recorded. This may be due to the vehicle not lingering long enough to trigger a motion recording. We may have to live with this behavior.

Water Testing

- See "This Week at Lake Tish" email sent 09/13 for full water testing report. Bottom line is that the lake is in great health.
- Highlights from the meeting:
 - Water is being tested every 2 weeks. Last inspection was last Friday Sept. 9th. Will continue to test every 2 weeks through next summer, starting in May through September 2023. We will not know if more chemical treatments are needed until next spring.
 - Positive findings overall. Planktonic algae bloom has subsided, water is a lot less green and clearer.
 - o Very little Southern Naiad vegetation found.
 - o Seeing grass carp in the 12"-16" range.
 - Planktonic algae bloom will result in record growth of fish this year.

LTPOA September continues from previous column Old Business

- Resolution of ongoing issue in M-N cove regarding restoration of the community property area.
 - Silt fence is installed.
 - O Property owner contracted Matt Holloran to clean out the last 100 feet from creek to the water front, then seed and straw the back portion. Jon has determined that the back portion is now completely overgrown with weeds and saplings and therefore does not need the seed and straw to be done.
 - There were two costs to this agreement: 1) the survey 2) the work that Matt Holloran performed to restore the community property. The Board and the Lot Owner would split the total cost of these two items. In accordance with this agreement the Board owes the Lot Owner a balance in order to finalize.

Steve made a motion to pay the balance to the Lot Owner. Jon seconded.

Motion approved.

New Business

- George Goetz K24 Expressed concern regarding the condition of his next-door neighbor's property Fuller property (K25 & K26A). The Fuller property has been unkept for the last 2 to 3 months. The high grass draws mosquitoes and bugs. The Fullers own half of the circle drive which is also overgrown in grass and flowers which attracts deer. The neighbors on the other side of the Fuller's property are trying to sell their house which is made more difficult due to the unkept condition of the Fuller property.
 - The Board will ask our lawyer to send a letter to the Fullers to indicate they need to cut the grass.
 - Steve will call Jefferson County to ask they drive by the property to see if there are any county violations that need to be addressed.
- Anglers Association
 - Current members: Mark Stubits, Peter Rola, and Brian Stephens.
 - Steve contacted John Schulte from Busch Wildlife Area to get information regarding use of electroshocking as an aid to identify our fish population. John indicated it would be 2 or 3 years before we could perform electrofishing. He did send forms and information. One recommendation was to get the daily fishing report online to collect data. Electrofishing is performed on a day, at one period of time. If the weather is unusually bad or unusually good on that day you could get a skewed reading. Therefore, having the data collected over a longer period of time via the daily fishing report would provide a better overall result.

Dan Timmersman called Harrison Fishery to

get a report of all fish stocked to the lake back to 2012. He has generated a spreadsheet to document this information. Dan talked to Frank Harrison the owner of the fishery. They held a discussion of options to improve the fish population. Dan indicated he is seeing a

lot of small fish, mainly bass around the 12" to 13" range. These

bass are competing with the other bass and not winning, therefore they are not growing any bigger. Mr. Harrison suggested walleye should be stocked in November. The walleye will feed upon the smaller bass which will help the fish population in the future. No stocking has been done (with exception of grass carp) for last four years.

- How can we resume regular stocking of the lake? Some lake residents have expressed interest in donating to this effort.
- o Brian Stephens: He has been keeping a personal fishing log. In general, the largest fish being caught at Tishomingo has been approximately 12 inches. He supports the idea of an online daily fishing report. The best way to promote larger fish in the lake is to harvest the smaller fish. The fishing report will provide a way to understand how many fish are being harvested. In the past, we held fishing tournaments for adults and kids where any fish under 12" were held out for a fish fry, another way to harvest smaller fish from the lake.
- Goals
 - Increase the size of the fish in Tishomingo.
 - Define new plan for stocking and harvesting fish. Include a budget to support the plan – deadline by this coming spring if possible.

- Create plan to fund stocking the lake. The Board will donate \$1,000 to this effort. Aluminum can collection – this is currently the main source of funds. How can we generate more funds for this effort?
- Dan Ewen when is the last time the dam outflow has been checked? Last check was in 2020 and all was in good shape. An evaluation is performed every 3 years. Next check is June of 2023.
- The next time the lake will be lowered will be in fall of 2024.
