Cookin' Cove

Holiday Dishes

One way to extend the holidays well into January, is to serve holiday dishes in January. So, assuming you're not fed up with the holidays (pun intended), let's start with two of our holiday favorites.

Pumpkin Cheesecake

This version of The Cheesecake Factory's Pumpkin Cheesecake is from "Top Secret Restaurant Recipes" (www.topsecretrecipes.com) and uses an 8- or 9-inch springform pan.

1-1/2 c graham cracker crumbs

5 T butter, melted

1 c plus 1 tablespoon sugar

3 8-oz packages cream cheese, softened

1 t vanilla

1 c canned pumpkin

3 eggs

1/2 t cinnamon

1/4 t nutmeg

1/4 t allspice

whipped cream

1. Preheat the oven to 350 deg F.

- 2. Make the crust by combining the graham cracker crumbs with the melted butter and 1 tablespoon sugar in a medium bowl. Stir well enough to coat all of the crumbs with the butter, but not so much as to turn the mixture into paste. Keep it crumbly.
- 3. Press the crumbs onto the bottom and about two-thirds of the way up the sides of the springform pan. You don't want the crust to form all of the way up the back of each slice of cheesecake. Bake the crust for 5 minutes, then set it aside until you are ready to fill it.
- 4. In a large mixing bowl combine cream cheese, 1 cup sugar, and vanilla. Mix with electric mixer until smooth.
- 5. Add the pumpkin, eggs, cinnamon, nutmeg, and allspice and continue to beat until smooth and creamy.
- 6. Pour the filling into the pan. Bake for 60 to 70 minutes. The top will turn a bit darker at this point. Remove from the oven and allow the cheesecake to cool.
- 7. When the cheesecake has come to room temperature, put it into the refrigerator. When the cheesecake has chilled, remove the pan sides and cut the cake into 8 equal pieces. Serve with a generous portion of whipped cream on top.

Our second holiday fave is a yeast bread I make in a bread machine, but with a bit more work can easily be made by hand in a conventional oven.

Rich Hirsch's Cranberry Orange Bread

2/3 c orange juice conc. (1/2 of 12-oz can, 7 oz by wt.)

1 c water

2 T honey (1.1 oz by wt.)

1/2 t salt

10 oz wheat flour blend (Gold Medal "Better for Wheat Bread" Speciality Blend)

10 oz bread flour

1/2 c cranberries, coarsely chopped (for a less tart bread, use Craisons or dried cranberries)

1 T sugar

1/4 c walnuts

1 T yeast

Combine all ingredients except cranberries into loaf pan. Since this is a yeast bread the orange conc. should be at room temperature when it is added. After the initial kneading (about 20 min. in my bread machine), spread out cranberries on a large flat surface, remove the dough from the loaf pan and knead the bread over the cranberries to work the berries into the dough. Remove the mixing paddle from loaf pan and return the dough to the pan to finish the baking cycle.

Agreat vegetable dish at November's LTIA dinner was made by Charlene Sansone. Add some cooked chicken or turkey to make a complete meal!

Charlene Sansone's Vegetable Stuffing Bake

1 medium onion, chopped

1 T vegetable oil

2 cans cream of mushroom soup

1 c process cheese sauce

1 16-oz pkg frozen cauliflower, thawed

1 16-oz pkg frozen corn, thawed

1 16-oz pkg frozen broccoli, thawed

1 16-oz pkg frozen brussels sprouts, thawed

1 6-oz pkg cornbread stuffing mix

In a large skillet saute onion in oil until tender. Stir in soup and cheese sauce until blended. Heat thoroughly.

In a large bowl combine vegetables and 1 cup stuffing mix. Add soup mixture and mix well.

Transfer the mixture to two greased shallow 2-qt baking dishes. Sprinkle with remaining stuffing mix.

Bake uncovered at 350 deg for 30-35 minutes or until vegetable are tender and edges are bubbly.

A nother great vegetable dish enjoyed at November's meeting was made by Liz Higgins.

Liz Higgins' Carrot Casserole

4 c sliced carrots (1 bag) or 3 cans

3 T butter

1/2 t salt

1/2 t pepper

1 c Pepperidge Farm herb seasoned stuffing mix or seasoned bread crumbs

1 medium onion, chopped

1 can cream of celery soup, undiluted

1/2 c cheddar cheese, grated

Cook carrots until soft, but not mushy. There is no need to precook carrots if using canned carrots. Saute onions in butter.

Stir in soup, salt and pepper, cheese, and carrots. Pour into greased casserole.

Mix stuffing with 1/3 cup melted butter. Sprinkle on top of casserole. Bake at 350 deg for 20 - 25 minutes.

Kathy Hopfer's Chili

- 4 lb ground beef
- 1 large onion, chopped
- 5 cans Brooks mild chili beans
- 2 cans Brooks just-for-chili tomatoes
- 4 pkg Chili Man dry chili mix

Brown the ground beef and drain to remove the fat. Saute the onions. Combine beef, onions, and rest of ingredients. Bring to a boil then simmer 2-1/2 hours. If necessary adjust consistency by adding water.

The Secret of Inner Peace



how much we will pay for outside help. The guard has said he could help and a resident's son who lives nearby has offered to help. Mr. Donaway said he leaves for work at 4 a.m. and he would be willing to help. Henry Brym volunteered to help maintain the equipment and Matt thanked him for this. Matt said that he was waiting to purchase salt until snow is imminent. Currently there is enough salt for one or two ice storms. Matt thanked not only the volunteers but also all residents for burning their leaves.

Finance Committee

Janet Hirsch reported that they had not had a meeting in the last month, but they were available to help the board as and when necessary. Ron thanked them and went on to say that thanks to Linda the assessment payments were now manageable. He said that we should keep after the people who had not paid because it becomes a hassle and is very expensive when handed over to the attorneys, even though it was inevitable that some would have to be

President Sansone then reported that he had been investigating using another attorney on a trial basis. He did not propose removing the cases that were currently with Attorney Tesreau. However, he said it was possible to file liens on delinquent property owners ourselves. This was a fairly complex procedure, especially in the follow up and someone had to be in court when the case came to trial or the case was lost.

President Sansone then brought up the progress of the Sewer Committee. He said that the first step was to say that we wanted a sewer district and the county would then produce the figures on the costs involved. We are working on this with our Commissioner and will produce the letter to him saying that we are interested. The next date for the Sewer Committee will be printed in the upcoming newsletter.

Janet Hirsch reported that the web site is now two years old and she thanked all those who had been involved. She reported that the newsletter had been mailed on October 23rd and the deadline for the next newsletter is December 19th.

Old Business

Matt Holloran introduced Mr. William Donaway who had attended the pre-board meeting on November 3rd. Mr. Donaway had a situation which he wanted to inform the lake about. He is building a new house on lots D58-62. He wanted to inform the lake that he and his wife were not the tyrants reported in previous minutes. As far as he was aware, he had conformed to all the requirements of the Jefferson county building department and had brought all the relevant paperwork for the board's inspection. He stated that although he was a builder and a contractor he was not building a spec house. He was building a house for his family to live in. He said that he had not been contacted by the building director as stated. The only people he had spoken to were Matt Holloran and Linda Fulford. He said that he had no problem from the board at the pre-board meeting but his problem lay with the building director who apparently had not been able to produce a list of questionable items. He said that he had contacted his contractor with regards to the problem of mud on the road and the homeowners across the road had also been in contact with contractor and the issue had been resolved. Mr. Donaway said that he realized that mud on the road had been very bad when construction commenced but they had tried to resolve that issue. Mr. Donaway then said that he got the impression that certain members of the board were not acting as board members but rather as "this is my friend" etc. He said that this was not what he expected and he was not aware of the extent of the building director's building experience. He said that Chris Townsend had suggested that the board hire an attorney to stop construction and that the building director had gone, unbeknownst to the board, to the Jefferson County building department to get the a stop work order on his property. Mr. Donaway concluded by saying that he felt that the younger members of the community would not be dictated to like this. He appreciated the fact that we listened to him and he hoped that the problem could be resolved but he had heard that many people had had a problem with the building director.

Following Mr. Donaway's statement, a comment from the floor suggested that the board had a problem with the building director. In response, President Sansone said that the bylaws did not state that the building director had to be a member of the board and at this time, he would like to recommend entertaining a motion to suspend the building director at this time and look into appointing another party. He said that Becky Harper had missed numerous board meeting and pre-board meetings and had caused much embarrassment at the meetings she had attended by her decisions, which had not been shared with the board members at large. On a question from the floor, President Sansone said that she was not being removed from the Board, just from the building director position. A discussion then followed on the issue of getting people to volunteer for the board and their qualifications for the various positions. President Sansone then asked for a motion that she be totally suspended from the building department, motion made by Matt Holloran seconded by Ray Lauer, motion passed unanimously. Following this, Bev Jost was appointed as the new building director. She will be assisted in this position by Ken Marschuetz and a committee of volunteers. Matt Holloran said that this new group would have to be diligent in informing the board on their activities, e.g. who they called and when they returned the phone calls, so that the building permits

could be voted upon in a timely manner. It was suggested that a form be developed for people to fill in and send to the board before the pre-board meeting for any type of building permit.

New Business

President Sansone suggested that we hold a dinner auction. He said that items such as a weekend in the Ozarks or a champagne ride around the lake etc. are donated and these are sold at auction. All monies raised would go to help pay off the loan. Because of the amount of time needed to organize this it would very likely be in March/April. Stan Schweiss said that he would provide a roast pig for the dinner. Numerous ideas were suggested. The LTIA would need to be contacted to ensure no conflicts. This will be put in the newsletter for suggestions.

Ray Lauer wanted to remind everyone to return the update sheets for cars and boats as soon as possible. This form was printed in the last newsletter.

Jerry Uhlenbrock reported on various items around the lake that needed consideration. President Sansone said that letters needed to be sent to the lot owners in question and we would then subsequently speak to them. Jerry said that there were at least three homes where the lakefront erosion was very bad and it was encroaching on their septic fields. He also said that two of the three were getting ready to sell their property. He said that when the property is sold it should be stipulated that the erosion should be replaced by the new owners. He also said that there were three homes where trees had fallen into the lake and the homeowners should be required to remove them. He said that the lake was not responsible for maintenance of the lots. A derelict pontoon boat would be picked up within the week. He produced

an item for insertion in the newsletter entitled "My first septic tank" advising homeowners on the care of the tank. Jerry also had a form from Jefferson County for residents to fill out if they notice any bad septic systems, They will come out and check them out. This form is also available on their website.

Jerry said that he received a report of a very large amount of E. coli upstream. This was eventually traced to a property on Hillsboro/House Springs Road. The pipe goes directly into the creek that feeds the lake. The property owner will be notified by the Jefferson County department. Only two coves now show any amounts of E. coli. Jerry had dated pictures for board review so that these could be monitored. Jefferson County will be monitoring the lake for us free of charge for at least another year. Discussion then followed on the trees in the lake. The fishermen said that trees were put in for fish protection. However, it was generally Christmas trees that were sunk. Jerry was talking about trees that had fallen into the lake due to erosion and these could not be left there, as they were an obstruction for the boaters. Matt or Ron would call those lot owners in violation. The question of how many unsightly tires you could have on a dock was also brought up.

There being no further business, Ray Lauer made a motion, seconded by Matt Holloran to adjourn.

There being no further business, the meeting was adjourned at 7:59 p.m.

Security Report

On October 23, Roger had occasion to visit the front gate area to do some adjustments with the video camera and he noted on the monitor that a pickup truck had stopped at the gate, which was in the down position, and the driver attempted to call a home owner. The video showed that he apparently received no response and at that time a passenger left the truck, and was observed forcing the gate open. After the truck passed through the man forced the gate back in the down position. Roger noted this had occurred only several minutes before he looked at the tape. He was able to observe the license number on the truck.

Wayne, our guard, was here at the time and was patrolling the roads. When Roger told him of what was on the tape, Wayne recalled seeing that truck on the south side of the lake. Within minutes, the truck returned to the gate and the driver was stopped. He said he had firewood to deliver to a homeowner, and when the proprietor did not respond to his call, he decided to raise the gate to give him access to the lake.

Roger notified me, and he also called the Sheriffs office. By the time I arrived at the gate, a deputy was pulling up also. He was informed of what was on the videotape, and he asked what we wanted to do. Roger had already told the violator the cost of repairing the gate would amount to \$250.00. The deputy gave the man an option to either pay the lake's cost, or charges would be filed with the prosecutor. The deputy took information for an offense report, and told the man he would allow five days before filing a report and seeking charges.

On October 25, the man contacted Roger and presented a check in the amount of \$250.00, advising he did not want to appear in court.

Again, we owe Roger our gratitude for his astuteness and for the manner in which he is handling gate operations.

Also, you will recall that in last month's report we told about a driver who broke our gate on the first night that it was operational after being broken all summer. Roger followed up on this matter, and was able to identify the responsible party. That person has paid us \$100.00 for the damages caused to the gate.

Tonight I turned over to Linda checks and currency totaling \$390.00, representing money paid for gate passes and for the above two instances of damage.

On October 28, a passenger in a vehicle who used a baseball bat or some similar heavy object damaged eight mailboxes along North Lakeshore Drive, apparently. The damages ranged from one box being severely damaged, belonging to Marilyn Meyer, to most receiving dents. These were random acts, and even Ron Sansone was a victim. I

received two calls from victims, and they were advised to contact the sheriff's office if they desired to file a report.

One resident informed me he and his wife have resided at the lake for 25 years and this is the first occasion they can recall of anyone having mailboxes damaged in this manner.

On November I, several inches of rain fell on the lake and somewhere in the late afternoon, the water level suddenly rose about 12 inches. We had guests at our home and one observed a pontoon boat from the north side quickly floating towards the dam. It had been parked on a lift. I telephoned Matt Holloran for help and he quickly came to our house on his boat, got me and we proceeded toward the dam and were able to "capture" the fleeing boat when it was about 200 feet from the spillway. Fortunately, the keys were in the boat and we were able to deliver it back to the owner.

This is a reminder that even though boats are on a lift, it is wise to also tether the boat to some weighted object along the seawall or elsewhere on your property.

Several years ago Ed Melchior manufactured wooden signs to warn drivers about the hazardous curves on our entrance road. This past week he noticed the signs, one with the wording "Dangerous Curve" and the other with an arrow, had been torn from their posts, and when he investigated further he observed the signs in the weeds alongside the road. He took them in for repairs and then reinstalled both signs yesterday. Thanks, Ed.

Finally, Roger asked me to mention the following issues relative to our security gate.

He has added an additional security camera which allows for a clear view of the surrounding area of the entrance, provides a clear view of the license plates on vehicles entering the gate and is motion sensed to conserve tape space and hard drive space. The gates have been rewired and now the entrance and exit gates work together when they are scheduled to be up.

By December 31, the gate system will be updated and all cards issued to people who no longer live at the lake, or have been lost or misused, will be removed from the access system. Therefore, it is important that everyone complete the form, which was made available in the most recent newsletter, and send it or give it to me so we can make our records current. A sign will be posted at the gate to remind residents of this issue. I need those forms by December 18 to allow us sufficient time to update our records by the end of the year. I want to thank everyone for their cooperation in this effort.

We are truly interested in making the lake area as safe as possible for all the property owners.


