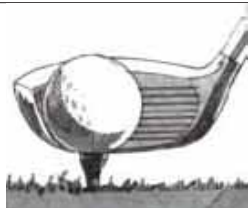

A Historical Perspective Of Lake Tishomingo

~ The Early Days, Part 9 ~

Elmer Richards continued that he remembered there was a farmer who owned the property north of the dam and the intent of Bastman was to purchase that property as the lake was being developed so the lake could extend to near Highway BB. But, a sale couldn't be negotiated. Had that plan worked out, Elmer added, the lake would measure about one-third larger than present.

And, of course, Elmer had a clear memory of the summer picnics. Signage was placed along Highway 21 and those signs attracted people to attend the three-day affairs. Tents were rented and placed near where the boat launch ramp is at present, and the picnics lasted three days. The women prepared all the food. A car obtained from McMahon Ford was raffled each year. He even remembered the open, illegal gambling that took place, but there was never any prosecution.

When asked about the lawsuit that resulted in the formation of the LTPOA, Elmer remembered that besides those mentioned as moving the litigation forward, Mr. Whiteman, Bob Schneider, an attorney who lived at the lake and represented the plaintiffs, and Irene Ross also signed the petition. Mr. Richards was interested in wresting the control from Bastman and Hurd, but Elmer couldn't recall if his dad entered into the suit. All the plaintiffs and a number of other property owners became disgusted with Bastman and Hurd because, in their opinion, they were not using the assessment fees for upgrading the roads and doing other general maintenance, and because they had failed to start the installation of sewers as they had promised.

Elmer also told about how he enrolled in the University of Missouri in 1957 and it was his dad's intention to build a house on their property. However, shortly thereafter, his dad suffered a stroke and although he lived for 20 more years, he eventually sold the property.

Morris Sallee's Memories – Of course, Morris wasn't one

of the early settlers here at the lake, but he had a wealth of information about certain issues. For example, he facilitated the purchase of the recently retired patrol boat in 1974 from D & G Marine, a boat store located at Gravois and McKenzie in St. Louis County. He added it was necessary to replace the \$180 boat that had been obtained during the summer months in 1956. That boat, according to Morris, had a transom that was too short, and every time the operator would place the motor in reverse, the boat would begin to sink. When no longer in service, Morris said, the old patrol boat was taken to the dam and sunk in 40 to 50 feet of water. The replacement patrol boat was equipped with a top compartment.

Morris recalled Mr. Hurd, and that he resided on South

Lakeshore with his wife. When leaving the lake during the 1970s, he first moved to the Covered Wagon Mobile Home Court on Old Highway 21, just outside Otto. Later, Hurd and his wife moved to Mountain Home, Arkansas for their retirement. Morris believes he passed away in the mid-1980s.

Just as Mike Dunphy had reported, Morris certainly was disappointed in the 1990s when the board reached a decision to remove the old, sturdy, steel structure bridge that carried traffic to South Lakeshore Drive. He indicated there was never any trouble with silt buildup in the creek because water flowed easily into our lake under that bridge. After the bridge was replaced, first with one tube and later with the dual tubes, the water often didn't have a free flow into the lake.

Even though Morris no longer was able to operate the patrol boat, he still maintained vigilance from his home looking for boaters who were here illegally. On occasion, seeing such people, normally here to fish, he had no qualms about driving to the beach and telling those anglers they have no business here, and directing them to leave the premises.

There is still a need to determine more about how the Lake Tishomingo Property Owner's Association came into existence, and that leads us to someone who has vivid memories about occurrences from long ago.

Reflections of Marlene Whiteman -

Like others who have provided valued information regarding the early days of the lake, Marlene and her husband, the late Robert Whiteman, were two of the people who settled here soon after the subdivision was being organized. She has vivid memories of the difficulties experienced because of the low water levels in those beginning years, the dry, dusty and sometimes nearly impassable roads, especially after inclement weather. She also has fond



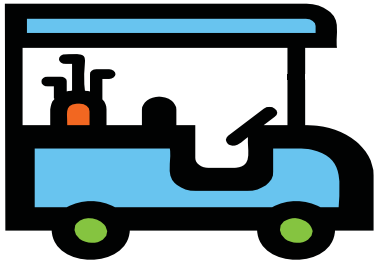

memories of the neighbors she and her husband engaged with here at the lake. Not everyone was friendly, according to Marlene, because there was a deep division between some individuals who owned property at lakeside and others who resided on the upper tier. For some reason, some people who lived near the lake felt they were being encroached by people who wanted to cross

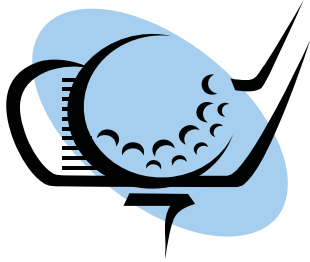
their grounds to reach the water activities.

Marlene, when interviewed, recounted how she and her husband and other couples would "patrol" in their vehicles on the lake roads during the evening hours. Their purpose was to stop and get acquainted with neighbors and encourage the upper tier residents to feel free to cross

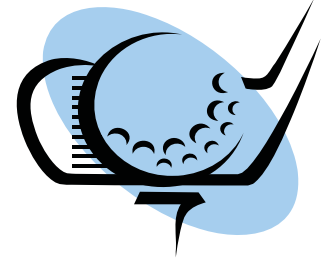

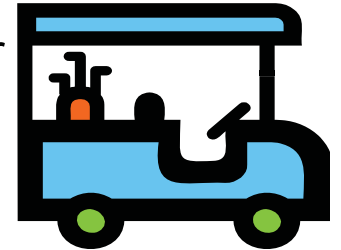

LTPOA Meeting Minutes May 10, 2011

Present: John Dauernheim, Janet Hirsch, Marilyn Meyer, Gerry Arbini

Thirteen property owners were also present.

Approval of Minutes

Marilyn Meyer moved that the minutes be approved. Motion seconded by Gerry Arbini. Motion passed.

Treasurer's Report

Marilyn Meyer presented the financial report. Motion made by Janet Hirsch to accept the report, seconded by Gerry Arbini. Motion passed.

Marilyn asked permission to pay one invoice:

Dale Wallen, grass cutting (community house lawn + entrance) \$305

Motion made by Gerry Arbini to approve payment, seconded by Janet Hirsch. Motion passed.

Marilyn asked permission to turn a delinquent property over to the attorney for prosecution and sale on the courthouse steps. Motion made by Janet Hirsch to proceed with the legal proceedings, seconded by Gerry Arbini. Motion passed.

Security

Friday afternoon May 6 someone removed the gate arm and John Dauernheim replaced it. John will try to engage a guard for the Memorial Day weekend. Gate will be in free-mode for Memorial Day (May 30) weekend.

Buildings

John Dauernheim reported that no new permits were issued last month. Current projects are being put up at a fast rate and all look fine.

Maintenance

John Dauernheim reported that the truck is still leaking gas from the fuel pump. He contacted Joey Hejnal to repair the leak and remove the salt spreader and plow from the truck.

John Dauernheim reported that Easter Fence will install a turnbuckle on the maintenance yard fence to correct the sagging gate problem. He is trying to dispose of old railroad ties from the maintenance yard.

Dam

Janet Hirsch reported that Clarue Holland is obtaining bids for the cutting of the grass on the back of the dam. Janet moved that Clarue be permitted to hire a grass cutter based on lowest bid and cut the grass this month. Motion seconded by Marilyn Meyer. Motion passed. Cutters that can cut horizontally grass horizontally are preferred to minimize rut formation.

Communications

Newsletter - mailed Monday May 2 and the color version was posted at website May 2. Deadline for next newsletter is June 20.

Sewer Project

Fifty STEP tanks have been installed on the north side and on the tanks on that side should be installed by the end of June. The contractor expects to have all tanks installed by Sept 1.

The contractor finished the 75,000-gal recirculation tank and is now working on the three treatment (sand) filters. The contractor expects the treatment plant to be operational by early July.

If homeowners do not have the electrical circuit ready to connect they will incur a substantial expense to connect at a later date. So make sure you have your electrical circuit installed and certified.

Old Business

John Dauernheim reported that he contacted a homeowner about moving his boat and trailers from common ground. The homeowner said he will be moving them.

A property owner removed his boardwalk from common ground at the lake front after the board requested the removal.

The Blacksher lawsuit about delinquent assessments is moving forward.

Marilyn Meyer reported the estimate for reactivating the well at the pump house, installing a pressure tank, and hydrant at the maintenance yard is \$3300 - \$3600.

Marilyn Meyer reported that we should rent a portable toilet for the lakefront recreation area. Janet Hirsch moved to do so. Motion seconded by Gerry Arbini. Motion passed.

New Business

John Dauernheim reported that we are asking for bids for cleaning the two lots that still have damage from the tornado of April 2010. The property owners will be charged if we have to clean the lots for them.

John Dauernheim reported that Ken Jost took him, Janet Hirsch, and Rich Hirsch to Raintree subdivision to watch the road patching and determine if the machine they are using would be suitable for our use. They all agreed that our roads need more extensive repair than what that machine provides. Ken will continue to investigate repair methods.

LTIA

Phil Overy gave a presentation about the need to replace the roof on the Community House. He is obtaining bids and suggested that the LTIA and the LTPOA work together to find a way to finance the project. John Dauernheim suggested that he also obtain bids on putting a gable roof on the building.

Barb McGlynn suggested that the annual election include a ballot issue asking for two percent of LTPOA assessments to be given to the LTIA for Community House building maintenance.

Administrative

We have two board positions open. Phil Overy volunteered to join the LTPOA board. Janet Hirsch moved that Phil Overy be appointed to the board. Motion seconded by Gerry Arbini. Motion passed. His appointment is for one month and will allow the board to conduct business at the June meeting since otherwise there would only be three board members present.

Dear Neighbor:

While working in unison with Jefferson County Sheriff's Department, Goldman Fire Department and other emergency services.

Janet Hirsch moved that the minutes be approved. Motion seconded by Marilyn Meyer. Motion passed.

Treasurer's Report

Marilyn Meyer presented the financial report. Motion made by Janet Hirsch to accept the report, seconded by Marilyn Meyer. Motion passed.

Marilyn asked permission to pay invoices:

Motion made by Janet Hirsch to approve payment, seconded by Phil Overy. Motion passed.

Security

Phil Overy was security guard on duty for 36 hours during the Memorial Day holiday weekend. He gave detailed shift reports and reported that overall everything went very smoothly.

Rich Hirsch reported that someone in a large dump truck tailgated in behind another truck and broke the gate arm at about 9:15 am on June 10. The first truck used the callbox and the gate opened. The trucks seemed to be traveling together.

Rich Hirsch installed a new gate arm and Russ Wilner put reflective tape on it. The old gate arm was nowhere to be found, but based on the video, it was probably smashed.

We will have to get new gate arms, that was our last spare.

Buildings

John Dauernheim presented a building request from Timmer-son, I38-I41 for new addition and attached garage. Motion made by Marilyn Meyer to approve the permit, seconded by Phil Overy. Motion passed.

Maintenance

John Dauernheim reported that the truck is still leaking gas from the fuel pump. He contacted Joey Hejnal to repair the leak and remove the salt spreader and plow from the truck.

Peerless Land Fill will remove the of old railroad ties from the maintenance yard. Cost is \$53/ton, one ton minimum.

BobCat battery had to be charged. It has to be running to remove the salt spreader from the truck.

Dam

Clarue Holland had the grass on the dam cut in May and suggested that it be cut again June 23-24 before the scheduled MO DNR inspection of the dam June 28 and the July fireworks. Motion made by Phil Overy to schedule the grass cutting, seconded by Marilyn Meyer. Motion passed. Cutters that can cut grass horizontally are preferred to minimize rut formation.

Communications

Deadline for next newsletter is June 20.

Sewer Project

Sixty-seven STEP tanks had been installed on the north side as of June 7. Forty-eight of those have also had pump assemblies installed and the north side tanks all should be installed by the end of June. The contractor expects to have all tanks installed by Sept 1.

Force main lines are being bored on the south side.

At the treatment plant the three sand filters have had the concrete walls and floors poured. The contractor expects the treatment plant to be operational by early July.

If homeowners do not have the electrical circuit ready to connect they will incur a substantial expense to connect at a later date. So make sure you have your electrical circuit installed and certified.

Old Business

John Dauernheim reported that Easter Fence installed two turnbuckle kits on the maintenance yard fence to correct the sagging gate problem but it is not enough. Easter Fence is supposed to replace one of the gate support posts to correct the problem.

Don Fendler, G37, promised to have the bridge removed from common ground.

Lots F9 and M15 still have tornado damage from April 2010. If the LTPOA has to clean those lots, the owners will be billed.

New Business

Vern Puryear inquired about purchase of lots K59, 60, & 64. The price for all three would be \$5000.

LTIA

For the Fourth of July fireworks display we have to put up signs and inform people that they cannot park along N Lake-shore Dr during the fireworks. The fire marshal will not allow the fireworks to take place if the Fire Department cannot get through the roads.

Administrative

Annual LTPOA meeting and election will be June 18 11:30am. There are five positions up for election and four candidates on the ballot. John Johnston agreed to be a write-in candidate and fill the fifth place.

Special guests at the annual meeting will be the engineers and attorney for PWS#13 to answer any homeowner questions.

In addition to sharing some memories about their early days here at the lake, Marlene also provided a cache of Tishomingo News copies that had been stored in her garage, dated for the thirty-year period between 1960 and 1990. She also told about how her husband and some others became disgruntled with the manner in which the management company was operating here at the lake, and thus they were the impetus in beginning a court challenge that eventually led to the formation of the Lake Tishomingo Property Owners Association. The court records were left in storage at the lake office, and have been located and reviewed. More will be told about the efforts of those gentlemen as this article progresses.

But first, let's review some additional information from the papers provided by Marlene, since the sampling contain many more details about those who were the first property owners at Lake Tishomingo.

In the August 1960 edition we discover the monthly meetings were being held at the Edmond's Restaurant located in St. Louis at 3185 Gravois. Also found in that paper was an article recounting how Bob Droege, Jr., along with another property owner named Pete Chouteau, while practicing scuba diving, discovered and brought to the surface two outboard boat motors. They were both in water having a depth of sixty feet.

In the October 1960 publication an article recounts how a volunteer group named the Goldman Auxiliary Police, a Civil Defense Unit, had been providing security services at the front entrance. They had accomplished the objective of keeping trespassers from entering the subdivision and fishing. The first weekend in operation the guards "turned away 38 cars with 103 passengers that admitted they were going fishing, swimming or hunting." That's an impressive number, for sure. All the volunteers had been authorized by the sheriff to work here and had received deputy status.

May 1961 found a motor was not available for the patrol boat, so one was loaned for the boating season from

Ruehl's Sporting Goods store, located at Highway 21 and Lindbergh Boulevard. In subsequent years, according to various articles in the papers, other boating supply stores loaned a motor so the patrol boat could remain operational.

The boat parade during 1961 was scheduled for a Sunday afternoon in May, rather than in July. That month's publication contains photographs of the attractive trophies that were awarded for the first, second and third place winners. There was even an official photographer employed to provide a record of the boats that had been entered.

Catching fish was hampered during the summer of 1961 by what was described as "bushy pond weed." To counteract this, lake management bought 100 lb. bags of copper sulfate, and property owners were encouraged to purchase a bag for \$17.50, so that it could be spread in a cove near their home.

There were changes announced by the Circuit Court of Jefferson County in August 1961, to support challenges made by some property owners regarding the size of boat motors. Plaintiffs had sought relief and asked the court to allow the increase of horsepower for boats used for pulling skiers. Judge Edward Eversole agreed and set the limit at 25 h.p. for boats used for such recreational purposes. Also, the judge decreed that "where the craft is a square house boat type of water transportation, a large enough motor or motors may be used to propel the craft at a speed of not to exceed

five (5) miles per hour." Finally, Judge Eversole directed that costs associated with the hearing would be assessed against the defendants, the LTIA.

This writer can attest, because of photos in the various summertime issues of the Tishomingo News there were at least two boats at the lake that would qualify as "square house boat" types, and although not presently in use one remains to this day. The boats were utilized on the days of the annual picnics to make regular trips around the shoreline of the lake so that property owners could take their friends for a tour. The one remaining boat can be seen in

storage on Lot K-34, owned by Margaret Hopfer. According to the photographs, signage was hung from the sides of the boat advertising it as the Lake Tishomingo Excursion Boat. Ruehl's Sporting Goods had furnished the second tour boat for use during the picnic.

Something new was seen at the lake in October 1961. Property owners erected the building at the entrance to protect the watchmen from the elements and to store their equipment. Lighting was soon to be installed, as was a two-way radio.

Also that same month, a group of men associated with the YMCA came to the lake to set up a scuba recovery team. One of those gentlemen was lake resident Ed Melchior.

In January 1962, property owners were reminded of the necessity to purchase their fire tags. The cost was \$6.00, with a one-dollar discount if paid prior to February 1. Anyone not possessing a fire tag, if calling the Goldman Fire Department, would be required to "sign a note or blank check to guarantee payment" before fire suppression operations would commence.

Moving to February 1962, the headline reads "Community House Soon To Become A Reality." LTIA officers signed a lease with owners of Lake Development Enterprises Inc. for land at the beach office next to the office Lots 24 and 25 in Block O so that a community house could be

Lake Tishomingo Community Sewer Project

The contractor for the sewer project, TGB Contracting, reports

- The sewer main lines are installed along the north side of the lake and are now being installed along the south side. As of May 31, there have been 11,279 feet of force main lines installed and 4629 ft of lateral lines.
- The force main that crosses the spillway from the south side has been installed about 25 feet behind the new spillway weir in the channel. One vertical section of pipe remains to be embedded in concrete.
- The contractor began installing STEP tanks on the north side and as of May 31, sixty-seven have been put in place.
- They will be focusing their construction effort on finishing the wastewater treatment plant as soon as possible so that the installed STEP tanks can be connected and put online. They expect the wwtp to be functioning and connections to begin in July.

Operator Wanted

constructed. Signing of the agreement took place during a dinner meeting at the Cheshire Inn. Construction costs were estimated to be \$14,000 and the building fund had only \$4,000, so the remainder of the money needed to be sought from the various property owners. It was hoped money would be available and the building could be completed by August 1962. Notes were to be sold for \$100 each and would be repaid by the Association at 4% annual interest.

Only people (like me) who are old enough will recognize the names of two people who were scheduled to be at the lake for the annual picnic on August 12, 1962. One was Ernie Heldman, a well-known local magician from St. Louis with an advertised program for both young and old. The other was Pat Fontaine, known for her weather reports 12 times a week on Channel 4 in St. Louis. A photo of Pat standing in front of her weather map, which depicts only Missouri and Illinois, is included in the publication. There was no sophisticated computerized information to assist weather reporters in 1962. The maps reflect the temperatures in the various local cities written on the map with erasable markers.

Remember: a homeowner's electrical circuit must be in place and certified when the contractor is ready to connect the STEP tank at the residence. Otherwise, if the electrical service is not installed by that date, the homeowner will incur substantial expense to connect.

The District is legally obligated to connect every residence to the central sewer system. Connection is required by the federal government, Jefferson County, PWSD #13 ordinance and Lake Tishomingo subdivision Restrictions.

There are still some homeowners who have not completed their electrical certification. The district sent reminder notices to those people. If the contractor is not able to put a residence online because the electrical service is not available, the homeowner will incur substantial expense when they are connected at a later date.

Any problems with the location of lateral lines or tanks will be coordinated by the resident inspector, Mike Larenson. Mike is headquartered at 5706 N Lakeshore Dr. He can be contacted at (314) 402-0880.



Also, it was reported the LTIA voted to not sponsor a fireworks display in the summer of 1962 in order that the monies could be devoted instead to completion of the community house.

Three sides of the community house and roof were constructed so the first meeting for the LTIA board was held in that unfinished facility on August 19, 1962. What is now the front of the building, as depicted in a photo, had not been built. The kitchen, rest rooms, plumbing, heating and lighting still were needed to make the structure complete.

There is an interesting article in the August 1962 issue of the Tishomingo News with the title of "Historical Landmark is Near Tishomingo." The landmark is the Belews Chapel, and the writer recorded how fifty years earlier there was a settlement called Belews Creek. A few houses, a country store, a post office and the chapel were the structures making up that settlement. A fire swept through the little community destroying everything except the diminutive chapel. Of course, the Belews Chapel remains today. Across Hillsboro House Springs Road is the Belews Cemetery, and the sign there indicates the first interment was in 1912.

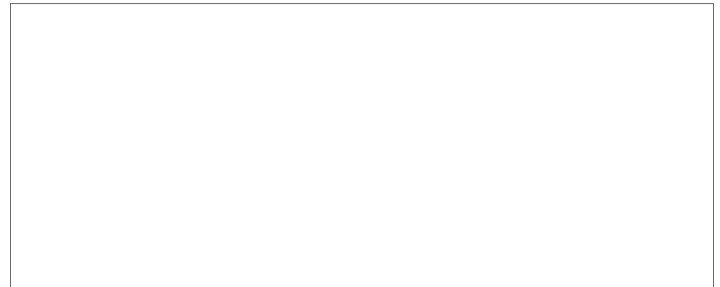
