## Marco Pietro Griffero 1929 - 2016

Marco can be remembered for many characteristics but most notably he can best be described as a friendly, fun loving, generous and non-assuming individual, always ready to assist a friend or neighbor who was in need. He possessed a keen sense of humor and he loved life.

Marco and his wife Pat first

bought property at Lake Tishomingo in 1970. Their first home was in the G-Cove but they are most fondly remembered for their second property, a house on G-14 which overlooked the main channel. The huge deck at that home allowed Marco and Pat to welcome visitors and they did that well, always having plenty of food and cold drinks.

Marco and Pat's marriage was blessed with four children, Marco, Maggie, Maria and Mike. They and

the kids spent many weekends and vacations here at the lake, making numerous friends. All four of the offspring, when young, learned to swim and water ski. Marco also loved to water ski, and he enjoyed that sport almost until his 70th birthday. Many can remember when he would be skiing and see friends who were enjoying a leisurely spin around the lake on their pontoon boat. Marco would make certain he would get as near as possible to the pontoon and then spray all the occupants of that boat. Once he did that, he would give thumbs up sign and laugh heartily.

Marco was a co-founder of Pietro's Restaurant, opened in 1960, on Watson Road in the southwest St. Louis city. He was the first to advise he wasn't really adept at preparing food, or even making coffee. But he had a knack at identifying the correct and most responsible people to work at Pietro's and as a result of his many talents, the restaurant became a very successful venture and popular eating establishment. It remains such today, even though Marco has been retired from the business for several years.

Surely his many friends can share innumerable stories about Marco's time here at Lake Tishomingo. We purchased our first home at the lake in 1990 and before we ever formally met Marco, we recall the weekend of St. Patrick's Day that year. We heard this loud music blaring from somewhere near our home on a Sunday morning. Heading outside with our children we saw this pickup truck heading up North Lakeshore Drive. Seated in the back of that

truck was Marco, dressed somewhat like St. Patrick, and throwing candy to anyone he saw. So many Tootsie Rolls flew our way that candy couldn't all be recovered that day. Marco had a trumpet that day, too, and he was generally having a ball trying to toot a tune on that horn. Years later after recalling that Sunday, when we didn't have an idea about his identity, we shared many laughs.

Marco readily shared his finances and good fortune with a number of others. He was a member of the Restaurant Association, belonged to the Holy Name Association at his parish, St. Ambrose on the Hill, the Professional Businessmen's Association, Italia America Bocce Club, and a member of the BackStoppers, the group whose financial assistance supports families of police officers and other first responders who have been killed in the line of duty.

He was a wine connoisseur, too. We would watch in amazement as he would take two bottles of wine, a red and white, and mix them in the same glass. Drinking that concoction, he'd remark that mixed wines always tasted better.

So much can be reported about Marco, but everyone who was acquainted with him can relish in their own memories of the good times Marco provided because of that friendship. And who among us who were friends of Marco cannot recall his antics each 4th of July, when his pontoon boat would pass our homes? Know what I mean?

So, we propose a toast to the friend of many, Marco Griffero. All of your acquaintances truly will miss seeing you at the lake. -- Ray Lauer

### LTPOA Meeting Minutes May 2016

LTPOA Minutes May 10, 2016

Board Members Present: Steve Blaha, Marilyn Meyer, Doug Leeker, Shelby Reneski, Roy Hummel, Ken Stojeba and Mike Steeno.

President Blaha called the meeting to order at 7:00p.m. There were 13 residents in attendance and all recited the Pledge of Allegiance.

#### President's Report

President Blaha welcomed everyone to the meeting and commenting on the beautiful weather.

President Blaha asked the board members if they read last month's minutes and if they had any additions, corrections or deletions. With nothing new to correct or add, Steve asked for a motion to dispense with the reading of the minutes and approve them as printed. Marilyn made a motion to waive the reading and approve the minutes and it was seconded by Mike. MOTION PASSED.

#### Treasurer's Report

Marilyn Meyer reported on the financial report for April 2016. Please see the attachment. Shelby made a motion to accept the financial report and it was seconded by Roy. MOTION PASSED.

Marilyn asked for approval to pay bills totaling \$2,465.94, which included Mooney Landscape (\$615.00), Steve Blaha for a boat battery (65.94), Mickey K's for the portable toilet (\$90.00), Dale Wallen for mowing the grass (\$545.00) and Red Oak for mowing the grass on the Dam (\$1,150.00). Shelby made a motion to pay the bills and it was seconded by Doug. MOTION PASSED.

Marilyn asked for approval to pay the portable toilet bill six months in advance instead of writing a check each month. Ken made a motion to pay the bill six months in advance and it was seconded by Mike. MOTION PASSED.

Marilyn asked if we could have Dale Wallen mow the grass to the four way stop signs before the garage sale this weekend and President Blaha stated that would be a good idea, so Marilyn said she would call Mr. Wallen and have him cut the grass.

#### Building

Doug Leeker reported he has an application from Rick Hannick, I-1, to replace all of the wooden dock. The first part would be to remove all the wooden dock and have someone haul it away and then he would take bids on replacing the dock. Ken made a motion to replace the dock and it was seconded by Marilyn. MOTION APPROVED.

Doug reported that Brian Stephens has submitted an application for a new patio and walkway on the lakefront, C-27 and C-28. After the Board examined the paperwork, Shelby made a motion to approve the new patio and walkway and it was seconded by Roy. MOTION PASSED.

Doug stated that he has an application from Ken Droege for a new concrete patio on the lakefront, M-23. After reviewing, Shelby made a motion to approve the new patio and it was seconded by Mike. MOTION PASSED.

Doug reported that he has an application from the Chandlers, A-51- A-53, for a fence for the backyard. Doug stated that he has seen the survey and recommends the approval. Ken made a motion to approve the new fence and it was seconded by Shelby. MOTION PASSED.

Doug stated that he has an application for a sunroom from Mike Goedecker at B-11. It was decided to wait for the approval of Jefferson County for the permit before we make a decision.

#### Security

Roy Hummel reported that a couple of paddleboats were mistakenly borrowed by the adult kids of a resident and left at a different dock. Roy stated that he spoke with the parent and resolved the issue.

Roy reported that he is trying to contact the individual who has been taken the gate arm off and entering. Roy stated that he has the name of this individual and Roy has spoken to his relatives here and they have not given this individual permission to be here. Roy stated that he plans to find the individual and talk to him before pursuing any legal action. Marilyn suggests that we send this individual a letter. Rich Hirsch reported that this individual has taken the arm off the gate four times and he has entered using two different vehicles. President Blaha stated that we would hold off sending a letter until we see if the new signage on the gate deters this person of interest.

Roy reported that GCI Security's rate has increased \$2.00 per hour this year. Roy stated that he would get the contract signed and returned to them this week. Since we plan to start security this Saturday for the garage sale, Roy stated that he would meet with the new guard this week to train him for his duties. Ken made a motion to accept the rate increase and hire GCI Security and it was seconded by Doug. MOTION PASSED.

#### Gate

Rich Hirsch reported that top gate code use for April belonged to Higgins and was used 71 times, an average of 2.4 times a day. Rich stated that when he contacted Mike Higgins, Mike thought this code had been cancelled; he has not been using this code. Rich reported that he has cancelled this code. Rich reported that the 2nd most used code belonged to JC Transport and they do a lot of business here, but it may be a good time to change their code as it was used 67 times in April, an average of 2.2 times a day. Kenny Marschuetz Jr's code was the 3rd most used code. It was used 52 times in April, an average of 1.7 times a day. This is a fairly new code and the usage has been creeping up.

Rich reported that on May 7th at 2:00pm a Tesla car came through the gate and the driver used his gate card to enter. Upon entering, the gate arm stayed up and eventually went down twelve hours later. Rich speculated that this might have been

Steve announced that he contacted Val Silhavy and Sheila Frauenfelder to mow the area near the creek inlet area and the guardrail, to the water edge.

Steve reported that he has a list of docks needing repair that John Dauernheim has given him. Steve stated that he and Ken would boat around the lake in June and add to the list, if needed, and will contact the owners to let them know that the lake will be lowered in October and they will need to make the necessary repairs at that time.

President Blaha stated, that in the last newsletter, he reported that every driveway must be paved for the first 20 feet from the lake road to protect the road. Steve stated that he would be visiting each of the homeowners that were negligent in adhering to this rule.

**New Business**

President Blaha reported that he would like to have the honeysuckle removed from the four-way sign to Steve Marler's house, 5551 Lake Tish Rd, and the brush trimmed around sales office and between community house and sales office. Steve reported that we also need to mow the grass around the community house, beach area, sales office, bus stop and along the roads on the north and south side and the entrance. He has received bids from Dale Wallen, Jeremy Christopher and Val Silhavy. The Board discussed the bids. After the discussion, Steve stated that we would continue to use Dale Wallen to cut the grass. Steve said he would

talk with Jeremy, because his bid was extremely out of line with Dale's on the mowing. It was decided to allow Jeremy to clear the brush around the sales office and the community house and Sheila and Val would cut the grass from the south side inlet creek to the swim area.

Steve said he had Dale Wallen cut the grass around the Lowery house that is vacant on the south side. Steve reported that the buyer of that property failed to take care of the liens by May 1st, so she forfeits the money she paid on it and it should go back to the county and they will resell the property. Marilyn suggested putting a lien on the house for the maintenance.

President Blaha reported that he would like the silt cleaned out of 5 ditches and culvert pipes. He said he has a proposal from Dale Wallen for \$550.00. Ken made a motion to approve the silt removal and it was seconded by Mike. MOTION PASSED.

Marilyn Meyer suggested having the grass mowed from the four-way sign and both the north and south side roads the end of June for the 4th of July.

A resident asked about the boulders at the beach area. Steve explained they would be used to line the creek to divert the water from coming across the road during heavy rainfalls.

Jerry Haas reported that he was having septic tank problems. Marilyn stated that he needed to contact the Sewer Board.

With no new business to discuss, Ken made a motion to adjourn and it was seconded by Doug. The meeting adjourned at 8:37.

boat, trailers and vehicles stickers.

Doug Leeker stated the need to have your lot numbers on your docks to help with coordinating building issues.

Doug Leeker reported that we have a ballot issue because of a resident requesting to move a path on his property. After lengthy discussions by the Board, the Board decided to give the property owners of Lake Tishomingo the choice to approve or disapprove the ability to relocate a path with strict guidelines. **Property Owners Comments**

## Lake Tishomingo Community Sewer Report

### Annual Service Visits

An agent of the sewer district will be visiting every residence in the subdivision to read the elapsed hours on the sewer pump meter. This information is being gathered so a maintenance schedule can be established.

In most cases, the meter is located on the side of the house near the STEP tank. So he will walk through the property and approach the house. The meter reader will have a badge identifying him as an agent of PWSD#13. He will show his credentials upon request.

### Payment Options

Sewer user fees are due by the 10th day of each month. Sewer user fees are **delinquent** if not received by the district on the 21st day of the month. This does not mean "check date" nor "postmarked." It means **received by the district**. Any accounts with balances due on that date will be charged the late fee.

Homeowners are encouraged to consider automatic payment of the sewer bill. The invoice postcards are issued the first of every month and payment is due on the tenth of that month. Payments not received by the 21st of the month are delinquent and subject to lien and prosecution.

Proper and efficient operation of our sewer system is vital to maintaining the quality of the lake.

### Missouri One-Call

The District is a part of the Missouri One-Call System. (The system was formerly known as "Dig Rite.") Missouri law requires that any person making or beginning any excavation notify MOCS at least three but not more than ten working days in advance, except in the case of an emergency.

Before you start any excavation project at your Lake Tish property you must notify Missouri One-Call to have the sewer and other utility lines marked.
