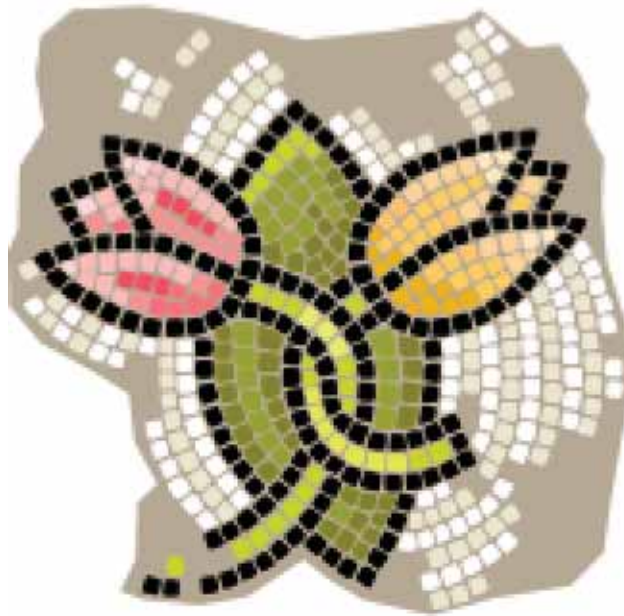

LTPOA Meeting Minutes January 13, 2015

Board Members Present: President Steve Blaha, Marilyn Meyer, Shelby Reneski, John Johnston, Roy Hummel and Ken Stojeba.

President Blaha called the meeting to order at 7:00p.m. There were 6 residents in attendance and all recited the Pledge of Allegiance.

President's Report

President Blaha welcomed everyone to the January 13, 2015 meeting and wished everyone a Happy New Year!

President Blaha reported he received a Christmas card from CEG Paving and enclosed in the Christmas card was \$100.00. Steve reported that he sent a thank you to CEG Paving for the monetary gift and informed them that he had used the gift of money to help Santa buy gifts for the little ones at the Christmas party.

President Blaha also thanked Jim Goodrum for the use of his bobcat while ours is broken. Mr. Goodrum has given it to us to use at a discounted price of \$100.00 a day, when we use it.

Minutes

December 9, 2014 meeting: Since the meeting minutes are available online, President Blaha stated he would accept a motion to waive the reading of them. Ken made a motion to waive the reading and it was seconded by Marilyn. MOTION PASSED.

Treasure's Report

Marilyn Meyer reported income of \$498.76. The income was a result of gate cards (\$25), Lauer closing (\$8.52), donation from the LTIA (\$200), yearly trailer rental (\$254.74) and interest of \$10.50.

Marilyn reported outflow consisted of a tarp to cover the ash and salt (\$43.73), the County Collector for property and personal taxes (\$1452.60), supplies for repairing the plow (\$27.71), monitor and keyboard for the gate (\$144.88), the portable toilet (\$90), snow plowing (\$45), returned postage (\$5.72) and mini park mulch (\$131.90). Additional outflow consisted of IRS filing and audit for the year (\$500), Department of Treasury IRS bill (\$874), Postmaster for stamps (\$19.60), Charter business phone at the gate (106.83) and utilities (\$106.28). The total outflow for the month was \$3,548.25.

The checking account has a balance of \$76,006.24. The Millennium account has a balance of \$200,348.17.

Roy made a motion to approve the report and it was seconded by Ken. MOTION PASSED.

Marilyn sought approval to pay bills, which included \$1500 to the sewer district for our portion of the work on the road to the sewer plant, \$90 for the portable toilet, \$2747.34 to Will Electronics for the camera system at the gate, \$20 to repair the tire on bobcat, \$135 for limestone for the boat ramp and \$145.07 for video installation. The total of the bills for approval came to \$4637.41.

Ken made a motion to approve the bills and it was seconded by Shelby. MOTION PASSED.

Building

John Johnston reported there was only one issue to report this month. Alfio Toscano has debris blocking the lakeside common area. There is wood scattered about and strings roping off the area that could cause someone to trip and fall. It was agreed that Shelby Reneski would write and send him a letter to remove the debris and string. The letter would also inform him to complete this by spring or we would have it removed at Mr. Toscano's expense.

Security

Roy Hummel reported that there was nothing new to report.

Gate

Janet Hirsch reported that Gordon Kassen would be handling the distribution of the gate cards and stickers. Gordon was present at the meeting and corrected Janet's report: Fred Steinmetz wants to continue to handle the distribution. Until Fred is ready, Ken Jost would handle the distribution.

Janet also reported the video system at the gate was installed on December 12, 2014. She stated the camera does a super job displaying the license plates and gate activity during the day and about 90% of the activity at night. She stated that we can view live images and captured images from home. To help with some of the night vision problems, we have installed an LED infrared lamp. Janet also reported that with the help of Will Electronics, we have experimented with some of the camera settings and we will continue to test the new camera's performance. One option would be to add the old close-up camera to the system, which would require a convertor box.

Janet reported that we are currently using a free copy of the recording software and she has asked for a price on getting a software license.

Janet stated we could view a demo tonight as they have it set up here, at the meeting. In addition she has sent all the board members instructions for computer and software access to the new system and if necessary she could set up a tech session if anyone needs assistance with working with the new system.

Maintenance

Ken Stojeba reported no new business except that the bobcat is still broken and he hasn't been able to contact the individual who does the repairs.

LTIA Representative

Shelby Reneski reported that the January meeting was cancelled due to the weather.

Trivia Night is scheduled for January 31st. Tables of eight are still available.

The February dinner meeting is scheduled for the 8th and the theme is "All About Bacon".

She also reported that we will be having a "Spring Fling" party on March 21st and that we are still working on the entertainment.

Shelby also informed everyone at the meeting that we are looking for volunteers for Mr. or Miss. Tishomingo for this year. If anyone is interested in the position, please contact one of the LTIA board members.

Finance

Janet Hirsch stated there was no new business to report.

Website/Newsletter

Janet Hirsch reported that the deadline for the next electronic version of the newsletter is February 20th.

Parents Club and Garden Club

No report on either issue.

Sewer

Rich Hirsch stated that it has been very quiet and there is nothing new to report.

Old Business

President Blaha reported that Mr. McLaren brought his equipment down and went up stream of the culvert pipes, as far as we own property and removed about six feet of silt the width of the creek, approximately 85 feet. He also reclaimed some of the boulders that had washed into the creek when we had a breach of the water coming over the road because of the debris block-

Security Issue

There was an unauthorized teenage party at the Community House pavilion late on Sunday night January 18. The suspicion of teenage drinking and improper use of the gate to allow entry caused a lake resident to call the Jefferson County Sheriff.

The next day the security director used the internet to access the new video camera system and view the recordings of activity at the gate.

Based on the video evidence it was clear that persons who were not property owners were letting in multiple vehicles in violation of security rules. Not only were the persons and their activities quite visible on the recordings, but the license plates of the vehicles they were using were read clearly and noted.

The LTPOA security director contacted the parents of the teenager hosting the party and reported the incident.

The organizer could have prevented the problems. He should have done the following:

1. Rented the pavilion through the LTIA
2. Obtained a party entry code for that evening
3. Instructed the participants that underage drinking will not be tolerated within the subdivision.

This past summer there were a few other security problems at Lake Tishomingo – several parties with underage drinking and serious abuse of gate entry codes.

To address these problems the LTPOA Board of Directors issued the following regulations:

- Party guests wishing to enter the subdivision must have either a temporary entry code that was issued specifically for the party or a valid gate card.
- Vehicles without the party-specific entry code will be prevented from entering by the guard until someone from the party verifies the identity of the visitors.
- As an alternative, the party host can furnish a list of guests invited to the party. The guard will check the list for each guest.

The Board is sorry if these regulations cause difficulties for admitting guests – but the abuses have resulted in disturbances to neighbors and other unwanted scenes at the lake. And these problems must be dealt with.

Keep in mind:

Underage drinking will not be tolerated

The Jefferson County Sheriff will be called as needed. Call 911 to report underage drinking.

LTPOA Meeting Minutes February 10, 2015

Board Members Present: John Johnston, Marilyn Meyer, Shelby Reneski and Ken Stojeba.

Vice President Johnston called the meeting to order at 7:04p. m. There were 14 residents in attendance and all recited the Pledge of Allegiance.

Minutes

January 13, 2015 meeting: Since the meeting minutes are available online, Vice President Johnston stated he would accept a motion to waive the reading of them. Marilyn made a motion to waive the reading and it was seconded by Ken. MOTION PASSED.

Treasure's Report

Marilyn Meyer reported income of \$6012.37 and included the sale of three LTPOA lots for \$6,000.00, closing on the Lauer property of \$4.26 and interest of \$8.11.

The cash outflow was \$17,885.88 and was the result of paying bills to C.E.G. Paving and Contracting Crack Filling, Limestone for the boat ramp and a tire repair, our part of the PWS #13 treatment plant road repair, Will Electronics for the IP HD camera, new video installation equipment and other reoccurring monthly charges.

After the monthly cash inflow and cash outflow, the checking account has a balance of \$64,132.73. The Millennium account has a balance of \$200,430.51.

Ken made a motion to approve the report and it was seconded by Shelby. MOTION PASSED.

Marilyn then submitted bills that needed approval for payment amounting to \$4684.97. These items included repairs to the Bobcat, the portable toilet rental, 4th quarter legal, the IRS, a new battery and snow plowing.

Ken made a motion to pay the bills and it was seconded by Shelby. MOTION PASSED.

ing the two culvert pipes. He realigned a strip of the rocks into a straighter line to help settle the silt. He had some rock brought in to replace what was not there so that it could be graded level all the way back from the lake to the culvert pipes. Mr. McLaren also removed the debris that had been taken out of the north and south side ditches, two years ago and hauled that away too.

President Blaha also thanked Steve Marler at the junkyard, for accepting the all of our sand.

President Blaha also reported that the siphon needs a new base to cradle it for support. We also need to make a new tap to fill the siphon pipe. This all needs to be accomplished before 2016, when we lower the lake again.

New Business

President Blaha reported that as we are all aware, it's the homeowner's responsibility to keep their ditches clean. However, getting this accomplished is a major problem. Steve said his concern is the uphill side, on the second tier side. The road is on a flat plane. The ditch is designed to run the water to a collector pipe that runs under the road and into the lake. However, trees are starting to grow up into the ditch and grabbing the debris and the result is the water is flowing onto the road. Steve said he spoke to Dale Wallen about the ditches where they form a "U" or "V" and clearing the brush and trees up to top of the "U" or "V", all around the lake and coves, where there is growth. The cost would be between \$4500 and \$5000.

Ken made a motion to have Dale Wallen cut the ditches and it was second by John. MOTION PASSED.

With there being no other new business, President Blaha asked for a motion to adjourn. Marilyn made a motion to adjourn and it was seconded by Ken at 7:36.

Building

John Johnston reported that the board had emailed approval of Chad Sutterer's dock at H35, which he had started constructing and had a permit May 8, 2013. The permit had expired, so a new permit was initiated.

John also reported that the board, through email, had approved Pat Niemeyer's (lot A35) replacement of a railroad tie seawall with environmentally friendly landscape timbers. There is no change in the shape or size of the seawall replacement.

Kevin Scheirich, at 6439 N. Lakeshore Dr (lots I51-58), stated that he would like to construct a 40X40 garage, attached to his house by a breezeway. He said the garage would have vinyl siding matching the house.

John made a motion to approve the building of the garage, pending the permit and all other necessary paperwork. The motion was seconded by Ken. MOTION PASSED.

Glenn Orton informed the board that in 2008 he requested to move his shed and wanted to know if he should update the form. John told him the permit expires within a year. Glenn asked if he should make an update and resubmit. John informed him that he had not seen a permit to move his shed and he doesn't think sheds can be moved from the original location. Glenn wants to move the shed five feet. John told him to put the permit together and we would discuss at the next meeting.

Security

John Johnston reported that there was a late-night unauthorized teenage party by the pavilion and the police were called to handle the problem. Marilyn reported that Roy Hummel called the parent of the individual that organized the party to inform him. The parent said he would address the problem with his son.

Gate

Rich Hirsch reported that the gate arm was broken on Friday and was a result of the company replacing the utility poles, tailgating through the gate. They came back two hours later and put a new piece of conduit in it. They didn't have reflective tape, so they used red, white and blue electrical tape. Rich said he replaced the electrical tape with reflective tape.

John reported that he saw a young man tailgate in through the gate, so he followed him home. The young man's mom came out when John arrived and knew who John was. John said he talked to both of them. John stated that he reminded them that people are watching and it is for their own safety not to tailgate through the gate.

Maintenance

Ken Stojeba reported that he would like to thank Joe Hernal for going above and beyond the call of duty the other night. There was an issue with the truck and it would not start, so Joe went home and got his daughter's car battery to use it to start the truck. Joe also stated that he used five gallons of his own fuel for the bobcat and would like to be reimbursed.

Website

Janet Hirsch reported the deadline for the electronic version of the newsletter is February 20th.

Parents Club and Garden Club

No report on either issue.

Sewer

Rich Hirsch reported one problem. There was a ruptured conduit at a residence on S. Lakeshore Dr., due to the owner digging up the electrical conduit with his Bobcat. This broke the conduit and wire connecting the control panel to the sewer tank. The owner reported the incident and repairs were made. Rich advised for owners to call Dig Rite to have utilities marked before digging.

Lake Tishomingo Community Sewer Report

Ruptured Conduit

The TP operator, Dave Axton, called at about 11am on Saturday Jan 31 to report that on Friday morning, Jan 30, a homeowner on S LSD dug up the electrical conduit with his Bobcat and broke the conduit and the wire connecting the control panel to the STEP tank.

On Friday afternoon the homeowner called Dave and told him the electrical connection was broken.

On Sat morning Dave's assistant, Dale, pumped the tank down so the sewer system could be used and to allow time for the electrical connection to be restored. Dave arranged for AA Quick Plumbing to come out and make the repair as soon as possible.

AA Quick Plumbing started work on Monday Feb 2 at 10am. There were two guys. I spoke to one and gave him a color-coded wiring diagram. I saw him again as he was leaving at about 12n. He said the system was restored and working again.

The moral of the story is: Call MO One Call (Dig-Rite) before you dig, so the electrical lines and pipes can be marked.

Missouri One-Call

The District is a part of the Missouri One-Call System. (The system was formerly known as "Dig Rite.") Missouri law requires that any person making or beginning any excavation notify MOCS at least three but not more than ten working days in advance, except in the case of an emergency.

Missouri law requires that anyone beginning any excavation notify Missouri One-Call

Before you start any excavation project at your Lake Tish residence you must notify Missouri One Call and have the sewer lines marked if near your excavation site.
