2016 4th of July Fireworks Display REGULATIONS

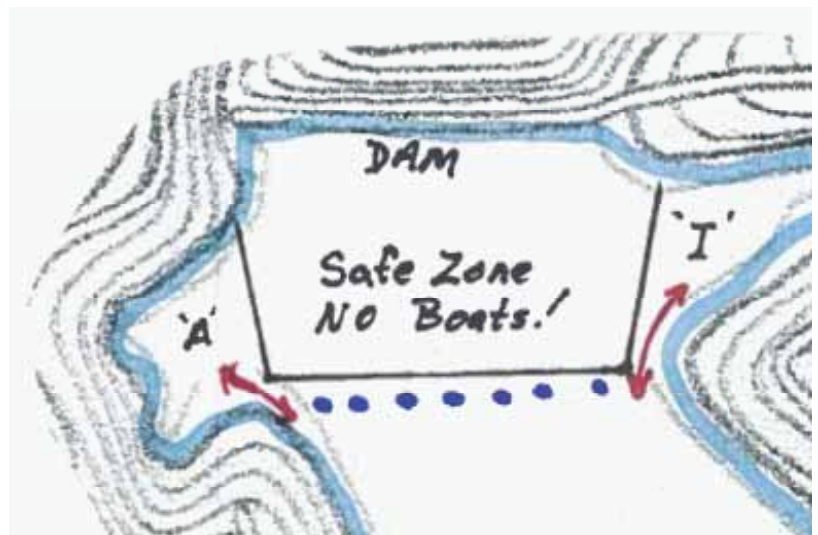
The state fire marshal has set a 500 ft. SAFE ZONE during the set-up until after the display. This means that the "A & I" coves will be off-limits to non-residents of these coves. The residents leaving and entering those coves will be required to do so using a route closest to the shoreline as indicated in RED on the map.

The SAFE ZONE will be marked with a line of buoys. DO NOT ENTER THIS AREA!!! The fireworks will begin at 9:30pm. It is MANDATORY that we follow the fire marshal's request or the display WILL BE CANCELED. Thanks in advance for your cooperation, the LTIA Board.

Greetings and Happy Spring! I would like to thank all of the lot owners that took advantage of the lake lowering this fall & winter to improve their sea walls, docks, & lake front areas. They look nice! It is great to see the lake starting to fill back up, we are currently about 16 inches below full pool.

Silt Accumulation

Not only is water filling the lake, also the silt at the beach, boat ramp & north bank areas is ever increasing. The lake is scheduled to be lowered again in 2020 and the silt must be dealt with.

Please use caution when boating in these areas. As the weather warms and the boat traffic increases I encourage everyone to familiarize yourself with the Water Rules & Regulations which can be found on page 6 and on our website at laketishomingo.com.

Community House Improvements

Assessment Increase

The LTPOA Board has approved an assessment increase of 75 cents per front foot to be put on the ballot at the Annual Meeting Saturday June 17. This represents an assessment increase of between \$37.50 and \$75 per year for an individual lot.

As goods & services continue to increase in cost, coupled with the need to remove silt and the desire to improve the Community House patio area, along with the day to day needs of the community, the LTPOA Board recommends approval. Below are the details found in our By-Laws, and a sample ballot. For absentee ballots please contact Ann Schatzman at 7741 Meadow Dr, Hillsboro MO 63050.

ARTICLE V MEETINGS OF MEMBERS

Section 1. The annual meeting of the members of the Association for the election of directors and for the transaction of such other business as may be brought before the meeting shall be held at the community center of the Association at Lake Tishomingo, the county of Jefferson, Missouri at 11:30 o'clock in the forenoon on the third (3rd) Saturday of June each year, and if that day be a holiday, then on the next succeeding Saturday.

Section 2. The polls for the election of directors shall be kept open for at least three hours after the opening of the meeting unless all the outstanding votes shall have been voted beforehand.

Section 3. A special meeting of the members may be called by the President, or by order of the Board, or by the holders of not less than one-fifth the total numbers of votes entitled to be cast at such meeting. Notice stating the time, place and purpose of such special meeting shall be mailed to all members entitled to vote NOT LESS THAN TWENTY (20) DAYS PRIOR TO SAID MEETING AND ABSENTEE BALLOT SHALL BE SENT TO EACH MEMBER WHO MAY REQUEST SUCH BALLOT IN WRITING.

Section 4. The owner or owners of record of platted lots on which the annual assessment has been paid shall be entitled to cast votes in all membership proceedings, on the basis of front footage of each lot as platted, with there being one vote for each ten (10) front feet, but not less than five (5) nor more than ten (10) votes per platted lot. Each matter voted on shall be determined by simple majority of the votes cast in this manner. If the record ownership is divided among several persons, then the votes must be cast by their unanimous agreement. Votes may be cast by an absentee ballot.

Annual Meeting and Election Saturday June 17, 2017

The annual meeting of the Lake Tishomingo Property Owners Association will be held June 17, 2017 at 11:30 a.m. at the Community House. After the meeting the voting for the election will begin. The polls will remain open until 2:30 p.m. Directors will be available for your questions.

Ballot Items

- Two positions on the LTPOA Board of Directors
- Ballot issue to raise the regular assessment by 75 cents per front foot. This represents an assessment increase of between \$37.50 and \$75 per year for an individual lot.

To place your name on the ballot

1. The candidate must be a lot owner in Lake Tishomingo Subdivision.
2. All 2016 assessments must be paid in full including any lien fees, interest, and attorney fees.
3. The candidate must submit a letter, in person or by mail requesting his/her name be placed on the ballot giving full name, mailing address, block letter and number in the subdivision owned by him/her to the election commissioner. Last date a filing can be accepted is May 17, 2017.

To vote in person

1. All assessments must be paid and up-to-date by June 16, 2017.
2. Present property owners must be recorded on the LTPOA assessment books by 1:00 p.m. June 16, 2017. Only one person can vote for co-owned lots.
3. Your ballot will be marked with the number of votes you will cast.
4. The number of votes is determined by the size of your lot (one vote for each ten front feet, but not less than five or more than ten per platted lot).

To vote by absentee ballot

1. To obtain an absentee ballot **you must send a self-addressed stamped envelope** to Ann Schatzman, the election commissioner, at 7741 Meadow Dr, Hillsboro MO 63050.
2. Include your name and lot number(s) owned by you.
3. Your completed ballot must be received by the election commissioner on or before 2:00 p.m. June 16, 2017 for it to be counted with the regular ballots for the June 17, 2017 election.

WATER ACTIVITIES RULES AND REGULATIONS

(Revised 2015 By LTPOA Board)

I. FISHING

1. Fishermen must be accompanied by a lot owner except by special arrangements made with the lake patrol.
2. Fish may be taken using a rod or pole. Only three rods or poles per person are allowed, and there is a three hook limit on each rod or pole.
3. Trotlines and jugs are prohibited.
4. The maximum number/quantity of fish per take, creel, catch or possession shall be according to the Tishomingo Anglers Association's current recommendations in accordance with the continuing effort to improve and modify each species and their population. These regulations are formulated after consulting our local fisheries biologist.

II. PATROL BOAT

1. The LTPOA patrol boat operator is responsible for water safety and enforcement of Water Activities Rules and Regulations and Boat Registration and Regulations.
2. The patrol boat will be operated in a safe and courteous manner and has the right-of-way on the lake at all times.

III. BOAT & MOTOR IDENTIFICATION

1. All boats must be registered with the LTPOA and must be the property of a lot owner.
2. Registration stickers will be furnished for those boats in compliance with the LTPOA Boat Registration Rules and Regulations. Stickers must be placed on the left (port) side of the craft near the block and lot identification.
3. Boats of all types must have the owner's lot and block number placed on each side of the craft in letters not less than three (3) inches in height. Placement should be toward the front of the boat if possible.

IV. BOATS - All boaters must be in compliance with Missouri State Rules and Regulations

1. The maximum boat length allowed is seventeen (17) feet excluding pontoon boats.
2. No boat shall be overloaded beyond the OBC rated capacity, or have a motor that exceeds the OBC maximum rating.
3. No hydroplanes, jet skis, inboard motor, or air boats (swamp buggies) are allowed. All outboard motors must be propelled by a marine propeller, NO jet drives are allowed.

V. PONTOON BOATS

1. Pontoon boats cannot exceed 24 feet in length.
2. No such type of craft shall be permitted unless the owner has a residence at Lake Tishomingo.
3. No such craft shall have any temporary or permanent sleeping, cooking, sanitary or toilet facilities thereon. No enclosing or screening of craft.
4. Pontoon boats are restricted to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal).

VI. MOTORS

1. No craft shall have attached a motor which exceeds a total of forty (40) horsepower.

VII. MOTOR BOATING

1. From 10:00 a.m. until 7:00 p.m. (prevailing time), maximum speed allowed.
2. From 7:00 p.m. until 10:00 a.m., all crafts shall be restricted to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal).
3. During ski hours all boats are to maintain a marine

pattern of counter-clockwise travel.

4. Zigzagging, facing toward the stern while operating boat, reckless speed, operating craft while intoxicated and any other form of careless or reckless operation is prohibited.
5. Minimum clearance of freeboard from gunwale to the surface of the water while operating shall be six (6) inches for any craft.
6. Every craft must be equipped with an approved type of life preserver for each person aboard.
7. Boats operating after dark must be properly lighted.
8. All boating must be at least 100 feet from shore.
9. Right-of-way shall be in the following order: sailboats, row boats, canoes, pontoons.
10. No boats are to enter swimming area under any circumstances.
11. Reduce speed of all craft while in coves or launch area to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal)
12. If you see or think that anyone is in distress, make effort to help and notify patrol boat.

VIII. SKI AND SURFBOARD SAFETY

1. Skiing or surfboarding is permitted from 10:00 a.m. until 7:00 p.m. (prevailing time).
2. Skier must wear an approved life saving belt or jacket at all times.
3. Keep boat and skier 100 feet from shore while operating.
4. All boats when pulling skiers must either be equipped with a rearview mirror or have at least two occupants.
5. Travel counter clockwise at all times and circle counter clockwise when picking up a fallen skier.
6. Never drive boat so that skier is closer than 50 feet from any object.
7. Take signal from skier only and never sit on gunwale of boat.
8. Operators of boats pulling skiers must be at least sixteen (16) years of age.
9. Skiing from cove entrance is not permitted. Skiing should start and end up on the main body of the lake.

IV. SCUBA DIVING

1. Any property owner or guest scuba diving must have card signifying accredited course in techniques of diving.
2. Report to the patrol approximate area where you intend to dive from.
3. Display diver flag on float or boat and stay within 100 feet of same. Boats and skiers to keep 150 feet from flag. Remove flag after dive.
4. No scuba diving in ski lanes except when search and rescue diving is being conducted.
5. Fish and game Laws must be observed by divers.

X. SWIMMING

1. All swimmers must stay within fifty (50) feet of the shoreline except as noted below.
2. Swimming from pontoon boats is permitted (for short periods of time) in the lane between swimming, 50 feet from shoreline, and the ski lanes, 100 feet from shoreline.

XI. BUOYS

1. No buoys/tethered objects may be used in Lake Tishomingo without LTPOA approval.

XII. RESPONSIBILITY

1. Lot owners will be held responsible for the actions of their guests.

LTPOA Meeting Minutes March 2017

LTPOA Minutes March 14, 2017

Board Members Present: Steve Blaha, Doug Leeker, Shelby Reneski, Marilyn Meyer.

At 7:05, President Blaha called the meeting to order. There were 2 residents in attendance and all recited the Pledge of Allegiance.

President's Report

President Blaha asked the board members if they read last month's minutes and if they had any additions, corrections or deletions. With nothing new to correct or add, Steve asked for a motion to dispense with the reading of the minutes and approve them as printed. Marilyn made a motion to waive the reading and approve the minutes and it was seconded by Doug. MOTION PASSED.

Treasurer's Report

Marilyn Meyer reported on the financial report for February 2017. Please see the attachment. Shelby made a motion to accept the financial report and it was seconded by Doug. MOTION PASSED.

Marilyn asked for approval to pay bills totaling \$22,272.66, which included Tishomingo Quick Shop for gas (\$67.66), Mooney Landscape (\$1,705.00) and McLaren Grading Company (\$20,500). Shelby made a motion to approve paying the bills and it was seconded by Doug. MOTION PASSED.

Building

Doug Leeker reported that Michael Davis at 5705 N. Lakeshore Dr., lots O-46, 47, and 48 wants to replace his dock, which is at O-23. Doug stated that he inspected the site and the materials. Shelby made a motion to approve the dock and it was seconded by Doug. MOTION PASSED.

Doug reported that Gerald Arbini at 7784 Meadow Dr., lots B-1, 2, 3 and 4 wants to replace his boat dock at B-3. Doug stated that the site has been inspected. Shelby made a motion to approve the boat dock and it was seconded by Marilyn. MOTION PASSED.

Doug reported that the Schatzmans (Shealy Living Trust) at 7741 Meadow Dr., lot B-5, want to replace their dock. President Blaha stated that he has inspected the area. Marilyn made a motion to approve the dock and it was seconded by Shelby. MOTION PASSED.

Security

No report.

Gate

Rich Hirsch reported on the pros and cons of the clickers (remote control devices) for opening the gate. After a discussion it was decided to table the decision until we come up with the criteria for being able to have a clicker.

Rich stated that he re-routed the siren sensor signal through the telephone entry system for emergency vehicles. An email will be generated when the siren sensor opens the gate for an emergency vehicle. Steve stated that he sent Chief Peters an email informing him of the sensor and asked him, in his spare time, to drive through with his siren on to test the gate.

Rich reported that Rick Hannick's guests had problems with the gate when visitors were using his code and he sent someone to the gate with his card and it failed to open the gate. Rich stated that he looked into this and found out they were trying to use the directory code as an access code. When you try to enter an incorrect code 3 times, you are locked out for 90 seconds. Rich stated that directory codes will start with a 1 and if it's not a 1, it will be an access code. Rich said that guests should be told what kind of code they are given, so they can use it properly. Steve stated that he has taken a picture of the control box and he forwards that picture with directions on what to do to gain entry, with his guests.

Maintenance

President Blaha reported that Ken Stojeba has been working on getting information to Dale Wallen and Jeremy Christopher so that they can give us bids on grass cutting.

LTIA

Shelby Reneski reported that April 9th is the fish fry dinner.

Shelby reported that the LTIA will sponsor a "Rain Dance" party for April 22nd.

Shelby stated that the ice cream social will be on July 2nd and the fireworks will be on the 4th of July. Shelby stated that we have only collected \$4200 for the fireworks that cost \$7,000. We will continue to collect until the 4th to pay for this year. She stated that we usually collect for the next year at this time, so for 2018 we may not have fireworks because of the lack of funds. Steve stated that we plan to pass out information at the gate on Memorial Day weekend to let everyone know we are short on funds for the fireworks.

Shelby reported that Boat Poker will be on August 26th.

Finance

Janet Hirsch reported that people have been asking what we have paid in the past for silt removal, so she looked up the last two silt removals. Janet stated that the 1st big silt removal, since she has lived at the lake, started in 1999 and lasted through 2004. She stated that there was a dredge with a big vacuum on it and it sucked up water and silt and deposited the silt on the lakefront. Janet stated that we spent \$282,367 plus interest of \$6,000 on the loan, for a total of \$288,367. We did sell the dredge at the conclusion for \$75,000.

Janet reported that the 2nd major silt removal project occurred over the winter of 2007 and 2008. [The siphon was installed at this time and the lake was lowered eight feet below full pool.--jmh] McLaren Grading came in, dug it out and hauled it away in dump trucks. Because we did not have enough money to pay the whole amount, which was \$164,556, McLaren Grading extended us credit terms with no interest and we paid the balance over 16 months at \$10,000 per month.

Website

Janet Hirsch reported that the deadline for the newsletter is April 20th.

Sewer Board

Marilyn Meyer stated nothing new to report.

Water Testing

No report.

Dam

President Blaha reported that Clarue Holland emailed him and stated that when she returns from Florida, she will get the dam license and line up the grass cutting schedule for the dam.

Old Business

President Blaha reported that 46 property owners have responded to the Community House Improvement Survey, that was in the January newsletter. Steve stated that Janet Quillman has the list of those that have responded and she will be making calls to try and get at least a total of 100 property owners responses, which would be about 1/3 of the total property owners. LTPOA Meeting Minutes April 2017

LTPOA Minutes April 11, 2017

Board Members Present: Mike Steeno, Doug Leeker, Shelby Reneski, Marilyn Meyer, Roy Hummel and Ken Stojeba.

At 7:03, Vice President Steeno called the meeting to order. There were 5 residents in attendance and all recited the Pledge of Allegiance.

Vice President's Report

Vice President Steeno reported that there was to be "no wake" during the low water conditions and that we need a new election official, as Ann Schatzman is retiring.

Mike reported that President Blaha contacted Black Diamond Earthmovers, with regard to silt removal and Steve sent them pictures that Nick Holloran had taken with his drone.

Mike stated that Steve had sent Mildred Kley a letter regarding the possible sell of her property, which is located upstream of the lake, but he has not heard anything from Mrs. Kley.

Mike stated that we needed to vote on who would be able to get a gate clicker. After a discussion it was decided that if anyone had a Missouri disabled license plate or hang tag, they would be eligible to purchase a clicker for \$20. In order to get a clicker, they need to attend a Board meeting and show their disability tag or license and pick up their clicker. Ken made a motion to allow individuals with a Missouri disability tag or license plate, to purchase a clicker for \$20 and it was seconded by Roy. MOTION PASSED.

Mike stated that the north tube at the inlet creek needs to have a piece of bent floor cut out and concrete poured into the hole to prevent undermining of the culvert. Mike stated that Ed Hill and Steve said they will fix it.

Mike asked the board members if they read last month's minutes and if they had any additions, corrections or deletions. With nothing new to correct or add, Mike asked for a motion to dispense with the reading of the minutes and approve them as printed. Ken made a motion to waive the reading and approve the minutes and it was seconded by Doug. MOTION PASSED.

Treasurer's Report

Marilyn Meyer reported on the financial report for March 2017. Please see the attachment. Shelby made a motion to accept the financial report and it was seconded by Roy. MOTION PASSED.

Marilyn asked for approval to pay bills totaling \$1,065, which included Mickey K's portable toilet for six months (\$540.00) and Gill's Tree Service for a tree removal (\$525.00). Ken made a motion to approve paying the bills and it was seconded by Doug. MOTION PASSED.

Building

Doug Leeker reported that Michael Shea at 5821 S. Lakeshore Dr., lots H08, H09 and H10 want to build a dock. Doug stated that he will look at the site and get back to the Board.

Doug reported that Bob and Ann Garner at 5844 N. Lakeshore Dr., lot N17 want to build a patio. Doug stated that he has inspected the property and plans and everything looks good. Ken made a motion to approve the patio and it was seconded by Shelby. MOTION PASSED.

Doug reported that James Sivers at 6084 N. Lakeshore Dr., lots M17 and M18 wants to build a dock with boat lifts on both sides. Doug stated that he has inspected the area and reviewed the plans. Shelby made a motion to approve the dock and boat lifts and it was seconded by Roy. MOTION PASSED.

Doug reported that Glen and Patty Deutsch at 6367 S. Lakeshore Dr., Lots D32, D33 and D34 want to build a seawall and a patio with small walls. Doug stated that he has inspected the area and reviewed the plans. Ken made a motion to approve the seawall and patio and it was seconded by Shelby. MOTION PASSED.

Security

Roy Hummel reported that we will use the same security company as last year, GCI Security. The rate is the same as last year. They will start the weekend before Memorial Day weekend and continue through Labor Day weekend. There was discussion of having them patrol the water. Roy stated that he has spoken to them about that and they would have to purchase a different insurance policy and this would increase our price significantly. Roy stated that he would find out how much the rate would increase. Ken made a motion to approve hiring GCI Security again this season and it was seconded by Doug. MOTION PASSED.

Gate

Rich Hirsch stated that he has started looking at entry code use again and the code assigned to Ken Marschuetz Jr. was used 133 times in March which works out to be 4.3 times a day. The second most used code was one assigned to the Chandlers and they have sold their house. That code was used 59 times which works out to be 1.9 times a day. Rich stated that it might be time to change the Marschuetz code. The third and 4th most used codes were UPS at 1.7 times a day and the newspaper delivery person at 1.0 times a day.

Rich reported that the siren sensor was triggered 7 times, once by a diesel truck because of the noise it makes.

Janet Hirsch reported on the gate usage. She stated that in March access codes were used 542 times, gate cards 10,331, telephone entries 2,730, remote control 203 uses, and 7 siren sensor uses for a total of 13,815 transactions.

Maintenance

Ken Stojeba reported that Dale Wallen and Triple C provided bids for grass mowing around the lake common areas and Triple C's bid was much lower. Doug made a motion to accept the bid from Triple C and it was seconded by Shelby. MOTION PASSED.

Mike reported that Steve has a bid from Mooney to extend two culverts. The first is for a 30" extension at 5995 N. Lakeshore Dr. for \$2,160 and the second one is for a 12" extension at the west end of Meadow Dr. for \$1,120. Both culverts are too near the road-bed resulting in erosion of the embankment. Ken made a motion to approve the extensions of the two culverts and it was seconded by Doug. MOTION PASSED.

LTIA

Shelby Reneski reported that she heard the Fish Fry went well. She stated that the next event is April 22nd and it is a "Rain Dance". Admission is \$5 and there will be a DJ. The LTIA is selling 50/50 raffle tickets for \$5 to raise money for the fireworks for this year. The drawing will be that night. The fireworks fund is still short \$3,000. Shelby reported that the next dinner will be Mexican.

Wanted: Volunteer for Sewer Board

There is a new opening on the board of directors for PWSD#13. The primary purpose of the board is safeguard the water quality and beauty of the lake, by ensuring that the system operates properly.

Directors meet monthly to review the treatment plant and residential system operations and financial reports. In addition to overseeing the business of the district, directors frequently interact with the treatment plant operator and answer questions and provide assistance to homeowners.

The director qualifications are specified by Missouri law. The position is open to anyone at least twenty-five years old who has resided in the district for at least one year and is not delinquent in the payment of taxes or sewer fees.

If the district cannot get people to serve on the sewer board, the board will have to try to get Jefferson County to take over operations. If that happens, then property owners will lose local control of our sewer system. This includes the fee structure and district funds. That means that Lake Tish sewer fees could be used to support other systems.

If you have questions about the director position contact any director listed above.

The meetings are only once a month and generally last about an hour. The next meeting of PWSD#13 is 5pm Tuesday May 16 in the Sales Office, 5706 N Lakeshore Dr. The board can change future meeting times to accommodate the schedules of participants.

Directions to Arnold Rifle & Pistol Club (ARPC):

From St Louis take Interstate 55 South to Hwy M (Barnhart/Antonio Exit) At bottom of exit ramp DO NOT TURN but proceed South, this is Metropolitan Blvd. Go approximately 2 miles, look for Hunter Glen new subdivision on your right. ARPC is the next right turn. There will be a big mail box with ARPC 8343 on it on the road. To the right will be a big sign ARNOLD RIFLE & PISTOL CLUB. Pull up to the keypad on the left side (drivers side) enter key code 3006# you must hit the # sign for the gate to open. Proceed to Administration Bldg (one with 2 big blue 16" naval shells out front. Park to the East of the Administration Bldg.

FROM SOUTH OF PEVELY MO: Take Interstate 55 North to Hwy Z, turn left on Z go West to Metropolitan Blvd (right after you go under RR viaduct. Turn right on Metropolitan Blvd. Go approx. 1 mile look for ARPC mailbox and sign on your left. To enter Club read directions under directions from St Louis.

ALL FIRST TIME STUDENTS are required to take our FIREARM SAFETY AND MARKSMANSHIP CLASS. The parent or guardian must be present with student unless the student is with a boy scout for other Group. After the class they will proceed to the range to shoot 50-100 rounds of .22 rimfire ammo They are required to help put away shooting mats, target stands and rifles after shooting.
