4th of July Fireworks Display REGULATIONS

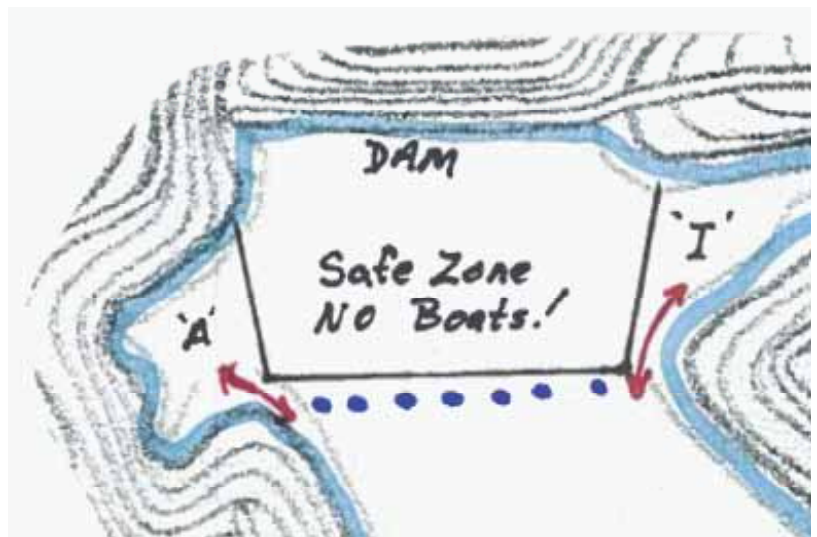
The state fire marshal has set a 500 ft. SAFE ZONE during the set-up until after the display. This means that the "A & I" coves will be off-limits to non-residents of these coves. The residents leaving and entering those coves will be required to do so using a route closest to the shoreline as indicated in RED on the map.

The SAFE ZONE will be marked with a line of buoys. DO NOT ENTER THIS AREA!!! The fireworks will begin at 9:30pm. It is MANDATORY that we follow the fire marshal's request or the display WILL BE CANCELED. Thanks in advance for your cooperation, the LTIA Board.

LTPOA Meeting Minutes March 2018

LTPOA Minutes March 13, 2018

Board members present, Steve Blaha, Ken Stojeba, Mike Steeno, Roy Hummel, Jon Riche.

At 7:00 pm, President Steve Blaha called the meeting to order. There were 3 residents in attendance, all recited the Pledge of Allegiance.

President's Report

President Steve Blaha welcomed everyone who attended.

President Steve Blaha asked the board members if they read last month's minutes and if they had any additions, corrections or deletions. With nothing new to correct or add, Steve Blaha asked for a motion to dispense with the reading of the minutes and approve them as printed. Ken Stojeba made a motion to approve the minutes and it was seconded by Roy Hummel. MOTION PASSED.

Treasurer's Report

Jon Riche read the financial report for March 2018. There was a cash inflow total of \$326.92 which included \$300 from assessments, \$15 from gate cards and \$11.92 from interest.

There was a total cash outflow in February of \$1,492.43 which included Ameren (\$126.81), Phone.com (\$18.43), Mark Stubits for gas and salt spreading (\$287.20), donation to the TAA for additional fish to stock the lake (\$1,000) and Charter (\$59.99).

The checking account balance as of March 2018 was \$102,631.91. The Major Projects Fund had an account balance of \$203,464.60 as of January 31, 2018. Interest accrued in the amount of \$78.04 resulting in a balance balance of \$203,542.64 as of February 28, 2018.

Shelby's written report of bills to pay in March totaled \$890.77 and included Charter (\$59.99), Phone.com (\$18.43), Ameren (\$123.90), Mark Stubits for clearing from the gate to the 4-way stop (\$500), Ken Stojeba for Bobcat battery (\$99.95) and Ken Stojeba for plow truck tag renewal (\$88.50). Ken Stojeba made a motion to approve the financial report and for paying bills and it was seconded by Jon Riche. MOTION PASSED.

Building

Steve Blaha reported on a driveway apron replacement located at A73. The proper permits have been obtained and Steve recommended approval. Ken Stojeba made a motion to approve the request and it was seconded by Roy Hummel. MOTION PASSED.

Correction from February: An application was received from Harry Heeger to replace the surface of a dock in front of C24. The prior minutes mistakenly reported this dock with lot C41.

Steve discussed the need for the clubhouse driveway to be replaced now that the patio is complete. Since the patio was expanded the current driveway does not match the grade, creating a large step up. The possibility of driveway repair or replacement was discussed at prior meetings. Matt Holloran has bid the driveway replacement at \$8,200 for brushed concrete and \$3,600 for asphalt repair. The new driveway would meet up with the new patio with no stairs, allowing access for those with disabilities. All were in ifavor of the concrete option over repairing the asphalt.

Ken Stojeba made a motion to replace the driveway and it was seconded by Mike Steeno. MOTION PASSED.

Gate

The most used codes were by Matt Holloran and Renee Hickinbotham who have current construction projects.

Rich discussed the need to change the code for USIC (contractor for Missouri One Call). Their code was used 40 times, which was unusually high and did not match the number of calls reported to PWSD#13. The board agreed to change the USIC code.

Maintenance

Ken reported that the Bobcat has a new battery and the plow truck tags have been renewed. Ken discussed the possibility of using asphalt millings to re-surface the parking lot in the community area. There is an excess of millings left over from the I-55 project. The only cost would be for delivery as the material is free. He stated he would further research the idea.

Steve reported the LTIA had a delicious corned beef dinner. Stay tuned for future events

Annual Meeting and Election Saturday June 16, 2018

The annual meeting of the Lake Tishomingo Property Owners Association will be held June 16, 2018 at 11:30 a.m. at the Community House. After the meeting the voting for the election will begin. The polls will remain open until 2:30 p.m. Directors will be available for your questions.

Ballot Item

- Four positions on the LTPOA Board of Directors

To vote in person

1. All assessments must be paid and up-to-date by June 15, 2018.
2. Present property owners must be recorded on the LTPOA assessment books by 1:00 p.m. June 15, 2018. Only one person can vote for co-owned lots.
3. Your ballot will be marked with the number of votes you will cast.
4. The number of votes is determined by the size of your lot (one vote for each ten front feet, but not less than five or more than ten per platted lot).

To place your name on the ballot

1. The candidate must be a lot owner in Lake Tishomingo Subdivision.
2. All 2017 assessments must be paid in full including any lien fees, interest, and attorney fees.
3. The candidate must submit a letter, in person, mail, or email requesting his/her name be placed on the ballot giving full name, mailing address, block letter and number in the subdivision owned by him/her to the election commissioner. Last date a filing can be accepted is May 16, 2018.

To vote by absentee ballot

1. To obtain an absentee ballot **you must send a self-addressed stamped envelope** to Emmy Riche, the election commissioner.
2. Include your name and lot number(s) owned by you.
3. Your completed ballot must be received by the election commissioner on or before 2:00 p.m. June 15, 2018 for it to be counted with the regular ballots for the June 16, 2018 election.

ATV Rules

- All riders must wear safety helmets.
- No more than two riders on an ATV.
- All ATVs must drive on the right side of the road and yield to all other traffic.
- All ATVs must obey the 20 mph speed limit.
- All ATVs must remain off other people's property.
- No riding on dam or lakefront area allowed.
- No ATVs from outside the lake are allowed on lake roads or lake property.
- All ATVs must be registered with the board and have lot numbers and lake identification stickers.
- No racing allowed anywhere on lake property.
- All ATVs must be equipped with adequate muffler systems
- All ATVs must have proper headlights and tail-lights to be run at night.
- No ATVs allowed on the lake when the lake is frozen.

If you observe anyone operating an ATV on private lots or off-road lake property you can report the trespassing to the Jefferson County Sheriff: (636) 797-5000.

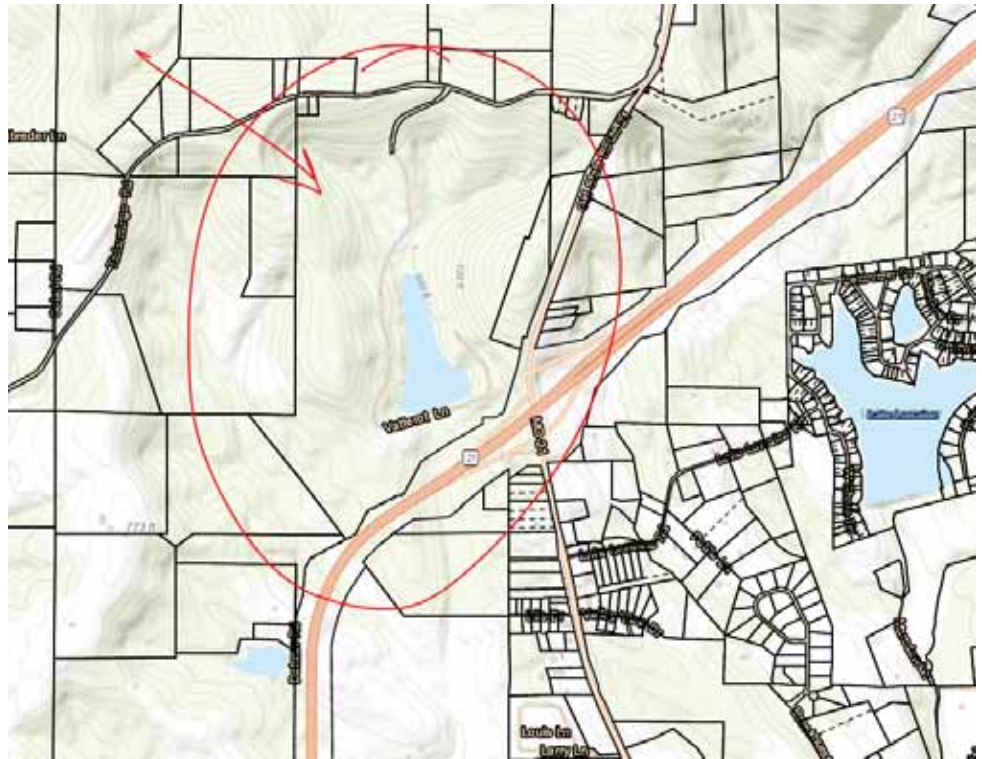

From the Planning and Zoning office staff:

The hearing is for a conditional use permit for mining by a blasting company. The intention is to mine sand by St Peters Sand Co.

The Planning and Zoning staff will evaluate the application and make a recommendation to the commission. That recommendation will be available online about a week before the hearing. So it should be available May 3.

The property is zoned LR2, large residential lot..



Attend the Hearing

There are many reasons to object to the issuance of the permit:

- there are about 2000 people in a 5-mile radius that will be subjected to noise, air, and ground water pollution
- an environment impact study should be completed before any permits are issued.
- Tishomingo Rd is a very long road that is the only access to many properties
- slow and heavy truck traffic will impede access for hundreds of people
- obstruction of Tishomingo Rd endangers anyone who needs Big River Ambulance or Goldman Fire assistance
- everyone on Tishomingo Rd, including Lake Tishomingo will be affected
- residential property values in the area will suffer

WATER ACTIVITIES RULES AND REGULATIONS

(Revised 2015 By LTPOA Board)

I. FISHING

1. Fishermen must be accompanied by a lot owner except by special arrangements made with the lake patrol.
2. Fish may be taken using a rod or pole. Only three rods or poles per person are allowed, and there is a three hook limit on each rod or pole.
3. Trotlines and jugs are prohibited.
4. The maximum number/quantity of fish per take, creel, catch or possession shall be according to the Tishomingo Anglers Association's current recommendations in accordance with the continuing effort to improve and modify each species and their population. These regulations are formulated after consulting our local fisheries biologist.

II. PATROL BOAT

1. The LTPOA patrol boat operator is responsible for water safety and enforcement of Water Activities Rules and Regulations and Boat Registration and Regulations.
2. The patrol boat will be operated in a safe and courteous manner and has the right-of-way on the lake at all times.

III. BOAT & MOTOR IDENTIFICATION

1. All boats must be registered with the LTPOA and must be the property of a lot owner.
2. Registration stickers will be furnished for those boats in compliance with the LTPOA Boat Registration Rules and Regulations. Stickers must be placed on the left (port) side of the craft near the block and lot identification.
3. Boats of all types must have the owner's lot and block number placed on each side of the craft in letters not less than three (3) inches in height. Placement should be toward the front of the boat if possible.

IV. BOATS - All boaters must be in compliance with Missouri State Rules and Regulations

1. The maximum boat length allowed is seventeen (17) feet excluding pontoon boats.
2. No boat shall be overloaded beyond the OBC rated capacity, or have a motor that exceeds the OBC maximum rating.
3. No hydroplanes, jet skis, inboard motor, or air boats (swamp buggies) are allowed. All outboard motors must be propelled by a marine propeller, NO jet drives are allowed.

V. PONTOON BOATS

1. Pontoon boats cannot exceed 24 feet in length.
2. No such type of craft shall be permitted unless the owner has a residence at Lake Tishomingo.
3. No such craft shall have any temporary or permanent sleeping, cooking, sanitary or toilet facilities thereon. No enclosing or screening of craft.
4. Pontoon boats are restricted to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal).

VI. MOTORS

1. No craft shall have attached a motor which exceeds a total of forty (40) horsepower.

VII. MOTOR BOATING

1. From 10:00 a.m. until 7:00 p.m. (prevailing time), maximum speed allowed.
2. From 7:00 p.m. until 10:00 a.m., all crafts shall be restricted to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal).
3. During ski hours all boats are to maintain a marine

pattern of counter-clockwise travel.

4. Zigzagging, facing toward the stern while operating boat, reckless speed, operating craft while intoxicated and any other form of careless or reckless operation is prohibited.
5. Minimum clearance of freeboard from gunwale to the surface of the water while operating shall be six (6) inches for any craft.
6. Every craft must be equipped with an approved type of life preserver for each person aboard.
7. Boats operating after dark must be properly lighted.
8. All boating must be at least 100 feet from shore.
9. Right-of-way shall be in the following order: sailboats, row boats, canoes, pontoons.
10. No boats are to enter swimming area under any circumstances.
11. Reduce speed of all craft while in coves or launch area to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal)
12. If you see or think that anyone is in distress, make effort to help and notify patrol boat.

VIII. SKI AND SURFBOARD SAFETY

1. Skiing or surfboarding is permitted from 10:00 a.m. until 7:00 p.m. (prevailing time).
2. Skier must wear an approved life saving belt or jacket at all times.
3. Keep boat and skier 100 feet from shore while operating.
4. All boats when pulling skiers must either be equipped with a rearview mirror or have at least two occupants.
5. Travel counter clockwise at all times and circle counter clockwise when picking up a fallen skier.
6. Never drive boat so that skier is closer than 50 feet from any object.
7. Take signal from skier only and never sit on gunwale of boat.
8. Operators of boats pulling skiers must be at least sixteen (16) years of age.
9. Skiing from cove entrance is not permitted. Skiing should start and end up on the main body of the lake.

IV. SCUBA DIVING

1. Any property owner or guest scuba diving must have card signifying accredited course in techniques of diving.
2. Report to the patrol approximate area where you intend to dive from.
3. Display diver flag on float or boat and stay within 100 feet of same. Boats and skiers to keep 150 feet from flag. Remove flag after dive.
4. No scuba diving in ski lanes except when search and rescue diving is being conducted.
5. Fish and game Laws must be observed by divers.

X. SWIMMING

1. All swimmers must stay within fifty (50) feet of the shoreline except as noted below.
2. Swimming from pontoon boats is permitted (for short periods of time) in the lane between swimming, 50 feet from shoreline, and the ski lanes, 100 feet from shoreline.

XI. BUOYS

1. No buoys/tethered objects may be used in Lake Tishomingo without LTPOA approval.

XII. RESPONSIBILITY

1. Lot owners will be held responsible for the actions of their guests.
