We have had a large number of new lot owners over the past year. Welcome to the Lake!! We encourage all lot owners to become members of the Lake Tishomingo Improvement Association (LTIA). The LTIA takes care of the Community House and pavilion. They have a monthly pot luck dinner meeting, and provide the main course. The LTIA also provides other entertaining activities from time to time, such as the Boat Parade on the 4th of July, the ever-popular Poker Run, and the upcoming Fall Festival on November 2nd.

First Right of Refusal. For those thinking about selling your home or lot, PLEASE don't forget about sending out the First Right of Refusal (FRR) form to your adjacent lot owners. For more on what the FRR is and the proper way to use it, please refer back to the Sept/Oct 2018 newsletter, pages 4 and 5. The newsletter can be found on our web site by clicking on Tishomingo News in the upper left corner. Information about FRR is also available on the website at http://www.laketishomingo.com/frr.html.

2020 Lowering of the Lake. The lake level will be lowered during the fall of 2020 for seawall and dock work. The siphon will be started on or about October 1, 2020. The plan is to lower the lake to about 5 feet below normal pool. In 2016 the siphon was started on October 1 and continued operation until December 3. There were several rain events during that time and the average water level drop was 1.22 inches/day. The final level was at 6.4 feet below full pool. Any questions about the lowering of the lake can be addressed at the LTPOA regular board meeting, which meets the second Tuesday of each month.

Boat Trailers. Fall is fast approaching and a lot of our lot owners use one of the LTPOA pontoon trailers to remove their boat from the lake. We are grateful for John Hunnicutt and Butch Hopfer for coordinating these trailers. The trailers are parked and locked in the Community House parking lot. They can be used by any homeowner to launch or remove a pontoon boat from the lake for a \$10.00 cash rental fee. To rent a trailer, please contact John at 636-274-6126 or Butch at 636-274-3791. These trailers are not permitted outside our community. Please, NO overnight car or trailer parking at the Community parking lots or the courtesy boat docks.

Autumn Leaves. Speaking of fall, when the leaves start falling and we receive a significant rain the ditches and culverts will start clogging. To help prevent this, make sure your driveway culvert is clear of debris and your ditches are kept open. Mid- to late fall we are planning to cut the brush above the ditches throughout the 7.5 miles of road within the lake community.

Tishomingo Anglers. The Tishomingo Anglers Association (TAA) will be doing their annual restocking program this fall. They collect aluminum cans at the entrance of the maintenance yard. Please, CANS ONLY. For those of you who keep track of the metals spot market it will come as no surprise that the market is way down, which means so are the funds. So if you

could find it in your heart to help out the TAA financially they will see to it that you, your kids and your grandkids have fish to catch. Lake Security. We were unhappy with the service that GCI Security Company was providing this season at the Lake. Our contract ended September 3rd. and we are currently looking into a better provider. We have upgraded our existing cameras and recording system in an effort to protect our property and deter criminal activity. Our best line of defense is our residents themselves. If you see or know of any criminal activity, contact the Jefferson County Sheriff's Department. Please remember that timeliness is most important! Waiting until the next month's LTPOA board meeting to report that you have seen or know of something may be too late. So PLEASE call the sheriff's office. The dispatchers are very well trained, work for us, and don't mind doing their job to help us.

The T.A.A. would like to discuss the "ever so delicate" topic of Water Willow. Being a scientist, I will lay out the information for everyone to make their own educated decision on this topic.

Water Willow Pros:

- Holds the banks and prevents erosion
- Provides a diverse ecosystem
- Provides habitat for many invertebrates, juvenile fish, ducks, insects, etc. (These organisms enhance the food chain for larger bass, walleye, crappie.)
- Helps with water clarity and feeds beneficial algae (zooplankton and phytoplankton)
- Creates areas that draw fish in to allow for higher hookup percentages.
- Creates areas for brim species to breed and make beds.

Water Willow Cons:

- Invasive tendency without proper management.
- Overrun dock/swimming areas of property owners
- Every plant being connected via the root system makes it hard to manage.
- Grows fast due to every stem being connected via root system

With the general pros and cons laid out, the T.A.A. would like to implement a proper management strategy. Make no mistake, we are not going to try to eradicate the plant from our lake. However, for those for whom the plant is being a burden by making access to the lake off their property difficult, we will be doing a herbicidal spraying two to three times a year.

Kevin Scheirich and myself (Brian Stephens) need some volunteers in order to be able to spray every needed lot early enough to give the herbicide ample time to dry/be absorbed before boating time opens up at 10am. We will meet at the boat ramp at 7:30am on either Saturday, October 26, or Sunday, October 27, depending on the availability of volunteers. Please email or call me if you are able to volunteer and indicate which day works for you.

We will need the land owners who want their water willow sprayed to email me at bstephens23@wustl.edu their lot numbers prior to the dates selected. We can only spray if the water willow is in front of your property; we will not spray your neighbors if they do not consent. The Lakeside Gardening group re-organized this spring and we sent out a survey to everyone via email to prioritize our Lakeside Gardening projects.

We asked, "Do you think the beautification of our community helps with the value of your property" and all respondents said, "Yes."

Then we asked, "Do you feel the common areas ... need to be cleaned up and beautified?" As you can see from the results of the survey on the graph, working on the

beautification of our entrance gardening areas is a priority for the 60 of us who answered this question.

Along with this survey we asked for volunteers to show up in the spring to help with cleanup of the gate, turn around, sales office and bus stop area. We had a good size group that showed up. We had some of our young neighbors who needed community service or A+ hours. We had some returning gardening members, new members and some board members. Overall the front entrance looks nice and has maintained its nice appearance throughout the summer. Thank you for all who showed up to do this work throughout the spring.

We also asked, "Are you concerned with the invasive plants . . . in our lake community?

Over 50% of the respondents were concerned, while 25% said that they did not know much about these plants and the harm that they are causing to us and our community. For more information about

Sewer Report

Denny Schaab, PWSD13 Director

(previously published in "This Week at Lake Tishomingo," August 22, 2019)

DID YOU KNOW?

- Lake Tishomingo sewer treatment plant meets/exceeds all EPA and DNR requirements
- The treatment plant is professionally serviced by Water Resources Management (WRM), Pacific MO, (636) 257-3976. NOTE: please use this number for all calls to WRM. If no one picks up, leave a voice mail. They will get back to you. Do NOT use any cell phone numbers that had been previously published.
- 100% of Lake Tishomingo's 239 residences, the Community House, and the sales office are serviced by the sewer district.
- The budget meets current expenses and repairs, services the debt and has sufficient reserve funds for long term maintenance and replacement of equipment when needed.
- The treatment plant is located behind the dam and has the capacity to handle 75,000 gallons of effluent per day.
- The normal operation averages 20,000 gallons per day. Currently there are 241 connections to the system, about half of which are full-time residents.
- The PWSD#13 board meets monthly to review and authorize payment of bills, review quality reports, and when necessary authorize liens for lack of payments.
- The district is managed by five volunteer board members who are all Lake Tishomingo homeowners.

LTPOA Meeting Minutes

Lake Tishomingo Property Owners Association

LTPOA Minutes July 09, 2019

Board members present Steve Blaha, Jon Riche, Doug Leeker, Ken Stojeba, Shelby Reneski, Mike Steeno.

At 7:04 pm, President Steve Blaha called the meeting to order. There were 32 residents in attendance.

President's Report

Steve asked the board members if they read the June minutes and if they had any additions, corrections or deletions. With nothing to correct or add, Steve asked for a motion to dispense with the reading of the minutes and approve them as printed. Ken made a motion to approve the minutes and it was seconded by Doug. MOTION PASSED.

Treasurer's Report

Shelby read the financial report for July 2019. June had a cash inflow total of \$2,922.11 which included \$50 from gate cards and clickers, \$2,859 from assessments and \$13.11 from interest. The cash outflow for June totaled \$5,305.67 and included Charter (\$59.99), Phone.com (\$18.63), Ameren (\$101.95), Happy Grass for mowing and trimming in May (\$1,050), Red Oak Landscaping for mowing of dam (\$1,100), GCI Security (\$2,193.50), T&C Electric permit fee (\$185), Jon Riche for printing of assessment letters (\$190.06), Krieg, Lohbeck & Co for tax return and report (\$145) and Steve Blaha for stamps and envelopes for assessment information letters (\$261.54).

The checking account balance was \$105,307.88 as of 06/30/2019. Interest accrued in the Major Projects Fund account in the amount of \$57.60, resulting in a balance of \$116,866.96 as of 06/30/2019. Mike made a motion to approve the treasurer's report and it was seconded by Ken. MOTION PASSED.

Shelby asked for approval to pay July bills totaling \$6,660.49, which included: Ameren Utilities (\$116.25), Phone.com (\$18.63), Charter (\$59.99), Happy Grass for mowing and trimming in June (\$400), GCI Security for June (\$3,890), Janet Hirsch for envelopes, printing and stamps for assessment invoices (\$283.20), Rottler Pest for annual termite inspection (\$276), Emmy Riche for election printing (\$30.22) and Reitz & Jens for dam consulting services regarding the potential slide (\$1,586.20). Ken made a motion to approve the treasurer's report and it was seconded by Mike. MOTION PASSED.

Shelby reported on 12 outstanding assessments for 2018-2019 totaling \$5,947.38. Each owner with an unpaid assessment has received a letter from our attorney. Mike made a motion to file liens on the individuals with an unpaid balance and it was seconded by Doug.

Building

Doug reported on an application from Dale Mckinnon at 5765 N Lakeshore Dr (O8) to remove 4 tree stumps from lake front and landscape. Doug recommended approval. Ken made a motion to approve the application and it was seconded by Shelby.

Security

Ken reported on some security issues stemming from the Ricotta residence. Barb, a resident, cited issues such as thefts and disturbing activity, which is creating fear among other residents. The home has been visited by

Jefferson County Police on multiple occasions, alleged renting of rooms and there are multiple derelict cars on the site. Mark Stubitts stated that he and a group of 9 individual

the site. Mark Stubitts stated that he and a group of 9 individuals confronted Mr. Ricotta regarding these issues.

There was a lengthy discussion between the board and the residents in attendance. A course of action was agreed

upon moving forward.

Ken is looking into hiring off duty officers from the Jefferson County Sheriff's department. This would be in replacement of GCI Security. There has been a recent change in the insurance necessary in order to hire an off duty officer. Ken is talking with the

Sheriff's department and our insurance agent regarding the matter.

Gate

Rich reported the emergency code was used over 4 times per day in the previous month. The code is obviously being used by non-emergency vehicles. Rich is in the process of contacting all emergency services in order to update their codes.

Maintenance

LTIA

The boat parade results were 3rd place Blaha, 2nd place Potter and 1st Place Schaab. The LTIA is in the process of getting picnic tables for the community house patio. The clubhouse is rented every Saturday in July, two Sundays and the pavilion has several rentals as well.

Boat Poker is scheduled for August 24th and the dock hosts are all set. The Fall Festival is set for the first weekend in November.

Old Business

Jon reported on the Brown, L-30 matter. There has been no contact from Mr. Brown since the board's offer was made regarding his property. Jon stated he would be reaching out to Mr. Brown.

New Business

Ken stated that with Roy Hummel moving, the board now only has 6 members. Ken asked if anyone wanted to volunteer to act as security officer on the board. Mark Stubitts, volunteered for the position. It was noted that Mark is the owner of Happy Grass and does work for the lake. Mike informed those in attendance that Mark will be abstaining from voting on any matters pertaining to his services. Jon made a motion to approve Mark filling the vacant position on the board and it was seconded by Doug.

Steve reported he has spoken with CEG paving and that we will be able to reach the end of N Lakeshore Drive this year, along with completing other needed repairs around the lake.

Board members present Steve Blaha, Jon Riche, Doug Leeker, Ken Stojeba, Mike Steeno, Mark Stubits

At 7:04 pm, President Steve Blaha called the meeting to order. There were 14 residents in attendance.

President's Report

Steve asked the board members if they read the August minutes and if they had any additions, corrections or deletions. With nothing to correct or add, Steve asked for a motion to dispense with the reading of the minutes and approve them as printed. Ken made a motion to approve the minutes and it was seconded by Doug. MOTION PASSED.

Treasurer's Report

Jon read the financial report for August 2019. July had a cash inflow total of \$116,127.70 which included \$100 from gate cards and trailer rental, \$116,008.80 from assessments and \$18.90 from interest. The cash outflow for July totaled \$6,379.53 and included: Ameren Utilities (\$116.25), Phone.com (\$19.17), Charter (\$59.99), Happy Grass for mowing and trimming in June (\$400), GCI Security for June (\$3,498.50), Janet Hirsch for envelopes, printing and stamps for assessment invoices (\$283.20), Rottler Pest for annual termite inspection (\$276), Emmy Riche for election printing (\$30.22) and Reitz & Jens for dam consulting services regarding the potential slide (\$1,586.20) and Red Oak for flagging the dam (\$110). The checking account balance was \$214,889.80 as of 07/31/2019. Interest accrued in the Major Projects Fund account in the amount of \$59.55, resulting in a balance of \$116,926.51 as of 07/31/2019. Doug made a motion to approve the treasurer's report and it was seconded by Ken. MOTION PASSED.

Jon asked for approval to pay August bills totaling \$3,581.47, which included: GCI Security for July (\$2,332), Happy Grass for cutting and trimming (\$1,050), Ameren (\$120.85), Charter (\$59,99) and Phone.com (\$18.63).

Doug made a motion to approve the treasurer's report and it was seconded by Ken. MOTION PASSED.

Building

Doug reported on an application from the Christophers (lot D69) to replace their dock in front of D36. The dock will be rebuilt to the same dimension. Ken made a motion to approve the application and it was seconded by Jon.

Doug also reported on a application for the Graham residence (lots C54, D48, D49) to replace driveway, apron and retaining wall. Ken made a motion to approve the application and it was seconded by Doug.

Doug also reported on an application for the Matzker residence (lots F23, 24 and 25) to replace one existing boat lift and add a 2nd lift and walkway in between. Doug viewed the area and stated all distance requirements were met. Jon made a motion to approve the application and it was seconded by Ken.

Doug also reported on an application from the Pohrer residence (K17, 18) to replace their existing boat dock to the same dimension. Jon made a motion to approve the application and it was seconded by Ken.

Security

Mark reported that GCI Security has been relieved of their duties. Their service and professionalism were subpar this season to say the least. Multiple avenues are being explored to replace GCI, including the Jefferson County Sheriff's Department. The final payment to GCI will likely be negotiated due to lack of services rendered.

Mark has contacted FedEx, informing them that their drivers have been speeding through the subdivision. The representative stated he would speak with his drivers.

Ken, Jon and Mark have been looking into the possibility of hiring off duty officers from the Sheriff's Department. This is not without its hurdles, including additional insurance and increased cost. However, the board has seriously discussed this alternative.

Maintenance

Ken and Steve discussed the construction of a cinder bin in the maintenance yard. This bin will be made of large MODOT block in order to hold cinder for spreading during the winter.

Ken discussed the need to order salt as well before the winter.

The Ryans requested that the subdivision pay to have a tree cut down in front of their property which is located on the parkway. Although other boards have approved this type of work in the past, it is the current opinion of the present board that property owners are responsible for maintaining the parkway in front of their property (ie grass, trees, walls, etc.).

Finance

After last month's budget meeting, Janet prepared the final 2019-2020 budget, which was available and viewed by the board members. Jon made a motion to approve the current budget and it was seconded by Ken.

Old Business

Jon reported on Brown, lot L-30. It has come to the attention of the board that L-30 has already been boundary adjusted

by Mr. Schweiss, prior to selling to Mr. Brown. The lake's attorney has viewed the recorded document from the Recorder of Deeds and it clearly states that originally platted lot L-30 and the adjacent 8 acres (to the rear) are now all part of Lake Tishomingo. It has also come to the board's attention that Mr. Brown has constructed a pole barn on this property. Mike made a motion to have the lake's attorney send a letter to Mr. Brown asking him to remove the structure, as our building regulations do not allow pole barns and it was seconded by Doug.

BREAKING NEWS!Burn Permit No Longer Required

The Missouri Department of Natural Resources Air Pollution Control Program no longer requires a permit to burn yard waste to include trees, leaves, brush and other vegetation. Campfires and other fires used solely for recreational purposes are also allowed. Fires should be supervised at all times.

For additional Open Burning Requirements, visit https://dnr.mo.gov/pubs/pub2047.htm.

Don't forget these additional safe burning tips, from the nolonger-required permit:

- Do not burn within fifty feet of any structure.
- Do not use petroleum products to start a fire.
- Do not burn substances that emit toxic smoke, or large amounts of smoke, such as roofing materials, tires, vinyl, plastics, railroad ties, etc.
- Keep an effective means of extinguishment, such as an extinguisher, garden hose or other water source nearby.
- Do not burn when the wind is fifteen mph or more.
