Do you remember a time when your boat wasn't running just right, or you needed a spark plug or some kind of a part? Of course it was a Sunday afternoon when all your company was over and they were ready to ski, boogie board, tube or just take a nice relaxing ride on your pontoon? It was easy to call or drive your car or boat by Morris Sallee's place. Years ago you would find him catching rays on his beach area, teaching his kids to ski, grilling for his company or working on a boat. He was the man who was never caught without a tan! I can't remember any part of my life that didn't include Tishomingo. One of my fondest memories with Dad was when he would take me skiing. Of course it wasn't the conventional way. At 5 years old he would strap the life belt on me and I would wrap myself around the front of his waist and the boat would pull us out of the water! Once we were up I would turn around and stand on the front of his skis and around the lake we would go! He had me out there on my own and on the slalom soon after. Many may not remember but my Dad was a great skier!

Morris's father-in-law introduced him to the lake and he raised his kids on the lake, and his kids raised his grand kids on the lake and his grand kids raised his great grandkids on the lake! Five generations spent countless hours in, on and around the lake. Our family gave up a lot of time on Father's Day, 4th of July, Memorial Day as well as ordinary weekends so others could enjoy the lake. Dad never said no to anyone who needed help with their boat. Before his health declined, we could really make him nuts by threatening him that we were going to put up a sign that he was "off duty" and that the "shop was closed" so we could

spend time with him. Of course that never worked. Dad loved to see everybody enjoy what he loved most and that was the lake! The summer of 2010 Dad couldn't walk very far without being completely out of breathe but it didn't stop him from asking us to take him on a boat ride around the lake. Struggling down the lawn and back up (with many stops in between) was worth it to be on the water. Anyone who knew him knew he had an incredible sense of humor. All of his funny little saying we called Morrisims and believe me he had a lot of them! As children who grew up on Lake Tishomingo for over 50 years we have wonderful childhood memories as well as into our adult life. Dad took pride in his home and the lake and he loved to show off both! Since his passing in January 2011 and selling his home months after that we have not been back. I can't remember a summer holiday when we weren't at the lake.

I think of all the lake residents who knew and loved my Dad and for that I am most grateful. Tishomingo is an incredible place to live or weekend at. I pray everyone who is part of the community sees the beauty it offers, joy that the scenery provides, the peaceful sight of the water after a long sunny day and feels how blessed you are to live in a place where wonderful memories can always be made. I hope that all who come to the lake love it and enjoy it as much as my Dad, Morris did!

LTPOA Meeting Minutes July 10, 2012

Board Members Present: President John Dauernheim, Marilyn Meyer, John Johnston, Gordon Kassen, Phil Overy and Ray Lauer.

Excused Absence: Kevin Seelbach

President Dauernheim called the meeting to order at 7:00 p.m. There were nine (9) people in attendance and all recited the Pledge of Allegiance. The president also welcomed Gordon to the board and expressed his appreciation for taking this position.

<u>Minutes of Meeting, June 12, 2012</u>: President Dauernheim made a motion to waive the reading of the minutes as they had already been printed in the Newsletter and were available on the web site. Marilyn seconded the motion. **MOTION PASSED**

Treasurer's Report: Marilyn read the financial information, indicating income of \$68.72, and expenditures of \$9,152.00. Some of the major items included an engineer's study and presentation regarding silt issues (\$1,110.00), roadside tree trimming (\$4,500.00), Sentry Security (\$749.65) and the Columbia Insurance Quarterly (\$814.75). \$231.10 was expended in the preparation and mailing of the May-June Newsletter. The entire report will be printed in the upcoming issue of the Newsletter.

Marilyn also indicated the checking account balance is \$302,852.75 and there remain two (2) delinquent assessments from 2010-2011, (both vacant houses), and the same delinquent assessments for 2011-2012. Phil made the motion to approve the report, seconded by John Johnston. **MOTION PASSED**

Marilyn then presented information on a number of bills that required payment, totaling \$2,604.01. Phil made a motion to approve the payments, seconded by Marilyn. **MOTION PASSED**

<u>Gate Report</u>: Russ Wilner advised there had been several complaints about the dial system not working when visitors attempted to get to property owners' homes but that situation apparently is now corrected. One person reported feeling a shock when using the gate pad. That matter will be monitored.

Also, Janet Hirsch reported we have received the new infrared camera to focus on license plates of vehicles leaving through the exit gate, and a new visible light camera is to work in parallel to this camera. The visible light camera would provide backup whenever the sunlight glare is too strong for the infrared camera. Members of the gate committee will work on installing the camera.

Security: Phil reported there was one complaint about loud music coming from an owner's home, and this was handled satisfactorily. Phil added that volunteers are needed to man the patrol boat and anyone interested should call Phil.

Building: John Johnston reported Edith Young has a contractor for replacement of the dock on Lot F-23, and the screened porch is being constructed at the home of George Goetz and Lynn Goetz, K-24. Also, after receiving a complaint about what appeared to be a dock being constructed without a permit, on Lot G-24, owned by the Mills, an investigation revealed they had obtained a permit from a previous board 4 years ago and didn't realize there was a time limit on when construction should have been started. They were allowed to continue building and the dock is now completed.

John also reported he had been contacted by Scott Schatzman with a request to get approval for a variance on a fence to be constructed on the property at 7741 Meadow Drive. Specifically, the request is for a 6-foot privacy fence so their dogs can be kept on the property. After discussion, it was decided the restriction would not be waived. Scott was present at the meeting, so he prepared a request for a permit and John presented it for consideration. Phil submitted a motion to approve the permit and Marilyn

seconded it. MOTION PASSED

<u>Maintenance</u>: President Dauernheim reported that he has been marking sections of the roads that will require surface repair and is seeking bids for the work that needs to be accomplished. When contractors respond with bids, he will consult with the board members. We are reminded this will be a costly venture.

LTIA Representative: Julie Johnston reported on the 4th of July activities, and the fact the fireworks had been cancelled. In conversations with LTIA board members, the recommendation is that the fireworks not be rescheduled any time this year, but that it be postponed until July 2013. She also spoke about the upcoming Poker Run on August 26, and the golf tournament on September 22.

Finance: Janet Hirsch reported the annual assessment letters had been mailed on July 2 to 344 property owners, for a total of \$165,585.20. A copy of the water rules was included with each invoice.

Board members decided to meet at 9 a.m. on August 4 and work with Janet to develop a budget for the new fiscal year. Anyone interested in developing the 2012-2013 budget is invited to attend, and if anyone has something that might be included in the budget should bring cost estimates to the meeting.

<u>Website</u>: The website has recently been updated with the results of the 4th of July boat parade and Miss Tishomingo coronation.

The deadline for the next Newsletter is August 20. Anyone preferring to receive the Newsletter as an electronic edition should advise Janet. Doing so would save the LTPOA and LTIA money for printing costs and postage.

Parents Club and Garden Club: No report on either issue.

Sewer Board: Janet reported TGB is finishing all bits and pieces that remain for the project. Any additional work for seed and straw will take place this fall.

<u>Water Testing</u>: Clarue reported testing would occur during July in 14 area of the lake, each site costing \$31.00, for a total of \$434.00. She will provide results at a later meeting.

<u>Dam</u>: No report this month.

<u>New Business</u>: There was a discussion about lowering the lake this fall, to address the silt buildup where water enters the lake, and after consideration of this matter, it was tabled for further review. Contact will be made with Mr. Marler to determine if he is willing to take any silt that would be removed as this would provide a cost saving.

Also, there remain four docks that owners have not responded about whether they will be torn down or repaired. President Dauernheim and Ray Lauer will follow up on this issue.

Phil Overy suggested the board should consider purchasing a bimini top for the patrol boat, because of the extreme temperature in recent weeks, but after discussion, this matter was tabled for further review.

The current owner of Lot O-13 asked the Board to consider addressing the silt buildup between that property and Lot O-15, by defraying the cost of extending a tube to carry water to the lake, and after discussion, this matter was tabled for further review.

There being no further matters to address, the meeting was adjourned at 8:01 p.m.

Gate Report (Rich Hirsch)

The security gate card reader computer stopped working around 1 am Sunday Aug.12. The security guard was present and removed the gate arm. Before that he called a member of the gate committee to report the problem. We should inform the guard that he should not be calling members of the gate committee or board members late at night. Rich has provided a gate key and instruction sheet for the guard shack instructing how to put the gate in the open position. Phil will make sure the guard learns how to do this whenever there is a problem. Rich rebooted the gate computer ~8am Sunday Aug 12 and it resumed normal operation.

Rich installed the new infrared license plate camera and the backup visible light camera for recording plates of exiting vehicles. They are now operational and Rich will be fine tuning the installation.

Security (PO)

G32/G33 Ryan, Replacing boards on 10' x 10' dock H15 Goodrum, Seawall with concrete footing B6 Marschuetz, Dock replacement 10' x 16' and seawall F26/F27/F28 Knoll, 183-ft concrete seawall B7 Ackerson, Seawall with concrete footing, approved pending submission of proper paperwork

Maintenance (KS)

Plans for a new 48' x 40' barn in the maintenance yard were discussed. It will include a 22-ft high 12-ft wide shed for salt delivery, two 10-ft high 12-ft wide garage doors and a 3-ft wide man door. The foundation and floor will be concrete. The estimated cost will be about \$30,000. The contractor may accept the worn out LTPOA tractor as partial payment.

This building will be conventional stick-built construction instead of a pole barn because the county building codes have recently changed. The county now requires a more substantial amount of concrete and reinforcement for the pole footing and a conventional building with a 3-ft concrete foundation is more economical.

Water Testing (Clarue Holland	d)

Clarue and Martin Holland collected and delivered 15 samples to the testing laboratory August 1. Thirteen of the samples were reported as being "less than 10cfu/100 ml" for fecal coliform. The sample from the upper creek near the bridge was above the maximum for whole body contact. (200 cfu/100 ml is considered unsafe for full body contact.) The reported value was 560cfu/100 ml. Clarue and Martin posted two "No swimming" signs at the upper creek and resampled that location, the inlet creek, and the beach area August 8. Again they hand delivered the samples to the testing laboratory. All the retested sites were reported to be safe for swimming.

Dam (Clarue Holland)

The grass on back of the dam will be cut in September. At some time the area where the ground hog was living should be dug to fill all the holes and tunnels to prevent damage to the back of the dam. Clarue will locate someone to take care of this.

Roads (JD)

John received three bids for the asphalt repairs that he outlined:

Dura Seal	125,600
Asphalt Art	124,000
CEGPaving	116,242

John identified additional areas to be repaired and asked the low bidder to resubmit. The revised bid is \$133,242.

The old asphalt in the areas to be repaired will be dug out and replaced with 4 inches of new asphalt. The repairs will be compressed with a 10-ton roller and will carry a one-year warranty. Since the budgeted amount is \$250,000 for asphalt repair, John will identify additional areas to pave.

Motion to accept CEG bid for road repairs: PO/JJ, passed John will also ask CEG for a bid to resurface the Community House driveway. He pointed out that the area was first paved in the 1990s, by the LTIA, when he was serving on that board. It was never intended to be driven upon. It was to be used only as a walkway up to the building. The consensus was that parking at

the top of the drive should not be permitted.

There was discussion about the garbage trucks damaging the roads. There are currently two services collecting trash in the subdivision, Waste Management and Beck-tel. The board agreed that we should have only one service in here and that competitive bids should be obtained from trash companies.

Silt Removal, Lowering the Lake (JD)

So far, McLaren Contracting is the only bidder for excavating silt from the inlet creek. And McLaren will reduce the cost if the work can be done under "dry" conditions. The lake will be lowered using the siphon beginning in mid October. It will be taken down far enough for the silt removal to be completed. That may be about five or six feet from full pool.

Motion to begin lowering the lake October 15: GK/PO, passed.

Tall Grass (MLM)

The board sent a letter to the owner of a property about the uncut tall grass in their yard. The property owner responded that their grass cutter found a large quantity of poison hemlock growing in their yard and he was afraid to cut it. They are waiting for advice from the conservation department about how to deal with the potentially toxic plants.

Patrol Boat (Steve Blaha)

The patrol boat is back on the water and is working fine. Steve had the boat out on patrol this past Saturday and Sunday. We still need volunteers to help with the boat patrol.

Motion to adjourn GK/KS, passed, 8:19 pm.

Changes, both plus and minus, from August 2008 through August 2012 can be attributed to several factors:

Cooler vs warmer test dates More vs less water feeding into the lake bringing with it pollutants from upstream farm fields More vs less ducks and geese on the lake

Test results indicate that there is no issue with the safety of the lake waters and are under the maximum Standards for Clean Water.

Security Report: Jul 10-Aug 14, 2012 By Phil Overy

During the latter part of July, I encountered two different fishing parties illegally using our lake, both parties were warned that they were trespassing and escorted off lake property.

Due to the alertness of a lake resident, Steve Blaha, and our security guard, Nick Costrino, two men were interrupted trying to put an inboard motor boat into our lake. They were escorted off the lake.

On Saturday, July 28th, it was reported that earlier that day illegal activity had taken place on the lake such as: boats going clockwise on the lake, a pontoon boat speeding being operated by an under- age driver pulling a tube with rider, all aboard were drinking alcohol without a property owner aboard.

Sunday, July 29th, received a report of two men speeding in and out of coves stopping in cove C to fish, one of them urinating into the lake in front of by-standers. Witnesses have identified these men, their boat and dock. This information is available for follow up.

August 7th, I informed a group of underage teens that it is lake policy to have a property owner present while operating a water craft.

August 11th a south side resident complained of loud music disturbing her peace, I along with our lake security guard responded to the north side party and asked them to please lower the volume. They cooperated and the complaint was considered closed,

August 12th, the entrance gate arm and scroll box malfunctioned the gate arm had to be removed by security.

Posting of code numbers at the entrance gate is prohibited.

The contractor has returned to complete the last of seed & straw restoration and will be out of the subdivision by September.30.

This has been a long and at times, very difficult project. It was supposed to be completed October 2011, but design changes, weather conditions, and scheduling problems all contributed to project completion delay until July. Any work TGB is doing now and for the next year is under the 1-year warranty wich began August 1.

We began to see improvement in the lake water clarity early this spring. If you wear goggles when swimming you will notice that underwater visibility is about seven feet. Better than I have ever seen it. There are probably other factors to consider, but I do believe that the sewer system has already improved the quality of our lake.
