Secondary Drowning

Secondary drowning – sometimes called “delayed” or “dry” drowning – can occur hours after a person, child or adult, survives an underwater drowning experience, or swallowing a lot of water. The individual may appear to be recovered, but the inhaled water is absorbed into the lungs and can damage the membranes necessary to exchange oxygen and carbon dioxide.

If your child has had a near drowning, or perhaps swallowed too much water, keep a close eye out for the symptoms of secondary drowning and take them to the hospital immediately. Symptoms can even take between one and 72 hours to appear.

Here’s what to look for:

- lethargy or extreme fatigue
- difficulty breathing
- irritability or mood swings
- chest pain
- shortness of breath
- persistent cough
- fever

Symptoms can even take between one and 72 hours to appear. Going to the hospital promptly is your best defense.

LTPOA News

Roads

The LTPOA's second biggest responsibility is our roads, and this is the current task at hand. We are presently addressing some ditch issues along the roads to help keep the water flowing in the proper and intended direction. Also we are waiting for several bids for the patch paving to be done on the south side roads.

Inlet Creek

The other issue being looked into is the south side feeder creek. As we all know this June was the wettest on record, which sent the water flowing over the road because of the debris-clogged culvert pipes. To my knowledge it happened three times this year. When this happens the road becomes impassable and the south side residences are isolated.

The blockage of the pipes and resultant flooding is a serious issue and so far we have met with three engineering firms and contractors to explore our options in an effort to prevent further damage.

The potential remedies discussed are

- additional culvert pipes
- altering the road to create a traffic calming area or swale
- replacing the pipes with a bridge

We do not have exact costs for these items at this time. It is hoped that by the next newsletter we will have all the data necessary to provide a chart explaining the pros and cons of each. So please be patient, we are trying to be forward thinkers and do what is best for all of the Lake Tishomingo Community.

This flooding also left us with a scoured area from the road down to the inlet creek. This is along the stream bank on the lake side of the bridge and will be filled back in with heavy rock. We do have another meeting scheduled to discuss repairing the scoured out area back to its original grade.

All of these solutions are expensive, but so also is fixing what Mother Nature destroys.

Dam

And by the way, our largest responsibility is the dam, and it too is requiring some attention. There is some water flowing thru the north groin area, so a sandbag dam will be constructed to make a shallow impoundment with a weir box to take water samples to determine rate of flow and origin of this water.

Volunteers will be needed to help construct and record this data. If you are interested in helping please contact someone on the LTPOA board.

2015 Annual LTPOA Meeting Minutes June 20, 2015

The annual meeting of the Lake Tishomingo Property Owners Association was conducted at the Community House on Saturday, June 20, 2015. The meeting was called to order at 11:28 a.m. by Vice-President John Johnston. Other board members present were Ken Stojeba, Marilyn Meyer and Shelby Reneski. There were fifteen property owners present and all recited the Pledge of Allegiance.

Since President Steve Blaha was not present at the meeting, Marilyn Meyer read the President's report that Steve had prepared. In the report, Steve thanked the residents for sharing several common goals. The first goal mentioned was water safety and the need to politely explain the rules to anyone doing something inappropriate. He asked that everyone read the water rules and regulations.

The second goal was home and property improvements, which reflect a sense of pride we share in our community.

The third goal we share is all of the volunteers within the community, which makes Lake Tishomingo the beautiful community that it is.

Steve's report stated that he was most thankful for the six other people that make up the LTPOA Board and that it is a privilege working with them. He was especially thankful for John Johnston for serving as Building Chairman and Vice President on the LTPOA Board and we will miss him and his expertise.

Steve's report indicated that the board is currently seeking bids for ditch and asphalt work on the roads and we are looking for a permanent fix for the overflow issues on the south side feeder creek.

The report stated that the lake would be lowered seven feet in the fall 2016 to allow for seawall and boat ramp repairs, as well as silt removal in the south side feeder creek.

A Special Thanks To Our Volunteers

Rich Hirsch, for keeping the gate working and for supervising the sewer system operation.

Janet Hirsch, who assists the board in the preparation of the budget each year, organizes the newsletter, sends the emails known as "This week at Lake Tish" and a host of other activities.

Clarue and Marty Holland, who head the dam committee, conduct the biological water quality testing and maintain the Emergency Action Plan.

Carol Stojeba, maintains the gate database.

Lynn Goetz, performs all the LTPOA bookkeeping and maintains the financial database.

Ron Hacker, maintains the vehicle and boat sticker database.

Ken Jost, interfaces with property owners for distribution of stickers and gate cards.

Brian Stephens, volunteered to be responsible for the algae, clarity and nutrient water quality test program from the Lakes of Missouri Volunteer Program.

Mary Leiweke, for the past ten years conducted the annual LTPOA elections.

Ann Schatzman, our new commissioner.

Property Owners Comments

Vice President John Johnston announced that the floor was open to the property owners.

Clarue Holland stated the need for property owners to clean up their property.

A homeowner asked if there were any rules stating that the empty lots, along the lake, need to be manicured back a few feet. Marilyn replied that it is listed in the bylaws that they must maintain their property.

Gerald Arbini asked if there was any plans to take care of the

water willow in the lake that was supposed to be removed back in 2007 - 2008. He stated that he has tried Shore-Klear without any results. John Johnston announced that members of the Anglers Association will be at the annual budget meeting and that might be the time to address the water willow issue.

A property owner asked if we could send out a quarterly newsletter by mail. She was informed that no one wants to take on the job of printing, folding, addressing and mailing the newsletters. Shelby Reneski announced that we have a few printed copies up at the sales office for anyone that does not have computer access. Mary Leiweke asked if we could have it printed by a copy company. She stated that she misses the printed copy. Janet Hirsch reported that previously 360 copies were printed and that someone needs to take responsibility for the printed copy if that's what they want. Mary is going to ask Lisa Mahoney what she would charge for a printed and mailed copy of the newsletter. Janet Hirsch stated that by distributing an electronic version, we could save about \$2,400.00 a year. It was suggested to maybe offer a printed copy by subscription. Mary is to look into the cost and report back to the board.

Marilyn Meyer announced that all of the financial material was available for inspection today if anyone was interested. She also announced that assessments would be mailed out July 1, 2015 and will be due August 1, 2015.

Ann Schatzman reported that she is replacing Mary Leiweke as the new election commissioner and thanked Mary for all her years of service. Ann announced that voting would commence at the conclusion of the meeting and end at 2:30. She then explained the voting process. Ann announced that there are three positions available and that Roy Hummel and Ken Stojeba are running again. John Johnston's term is ending, so his position is available. Ann stated that we would be taking nominations from the floor.

John Johnston reported on the rules for the 4th of July fireworks display and the need to stay out of the area marked by the buoys.

Barb Rohm announced that she was collecting for the fireworks and we need to raise \$6,000.

Mary Leiweke asked about the security officer and his hours and it was reported that he was on duty from about 8pm-2am Fridays through Sundays.

Homeowner Mike Steeno offered to run for a position on the LTPOA Board and told us a little about himself. He has been an owner here for about 4 years and loves it here. He stated that he is an attorney in St. Louis.

With no other questions or announcements, Ken made a motion to adjourn the meeting and it was seconded by John.

The meeting was adjourned at 11:58am.

LTPOA Meeting Minutes July 14, 2015

Board Members Present: Steve Blaha, Mike Steeno, Marilyn Meyer, Roy Hummel, and Doug Leeker.

President Blaha called the meeting to order at 7:00p.m. All in attendance recited the Pledge of Allegiance.

President's Report

President Blaha thanked everyone for attending the meeting and announced that our annual meeting took place on June 20th. Steve reported that out of that meeting we reelected Roy Hummel and Ken Stojeba to the board. He announced that Mike Steeno was elected as a new member of the board.

Steve reported that the 4th of July festivities went off spectacularly well without any problems.

President Blaha asked the board members if they had read last month's minutes and if they had any additions, corrections or deletions. With nothing new to correct or add, President Blaha asked for a motion to dispense with the reading of the minutes and approve them as printed. Marilyn made a motion to waive the reading and approve the minutes and it was seconded by Doug. MOTION PASSED.

Treasurer's Report

Marilyn Meyer reported cash inflow from delinquent assessments last year of \$927.00, trailer rental of \$10.00, Lauer closing \$4.26, gate cards \$50.00, an insurance refund of \$26.58 and interest in the amount of \$5.39. The income total amounted to \$1,023.23.

She reported that the cash outflow included Mickey's Portable Toilet (\$90.00), Wallen for grass cutting (\$500.00), the guard shack window repair (\$156.48), Red Oak Landscaping for cutting the dam twice (\$2,300.00), new resident welcome baskets (\$59.24), Charter for 2 months for the gate phone (\$219.25), Val Silhavy for clearing ditches (\$200.00), Postmaster for stamps to mail assessments (\$169.05) and utilities (\$109.50). The total cash outflow amounted to \$3,803.52.

Marilyn stated that after the monthly cash inflow and cash outflow, the checking account has a balance of \$39,174.02. The Millennium account at the end of May had a balance of \$200,757.44 and interest to this account was \$88.00, so the total Millennium account balance at the end of June was \$200,845.44.

Marilyn reported that we still have one delinquent account for 2014/2015.

Marilyn asked for approval to pay bills totaling \$7,738.78, which includes Red Oak for mowing the dam (\$1,150.00), GCI Security for May and part of June (\$2,118.04), Door Controls for gate cards (\$499.63), ink and paper for the newsletter (\$116.00), the portable toilet (\$90.00), and Mooney Landscape for the sales office sidewalk (\$780.00). Additional expenses to be paid are Rottler Pest Control for the sales office for the year (\$276.00), paint to mark the roads (\$7.90), Dale Wallen for mowing all the roads and the entrance (\$2,150.00), sand and pea gravel for the beach area (\$454.00), assessment supplies (\$75.52) and oil for the boat (\$21.69).

Roy made a motion to pay the bills and it was seconded by Marilyn. MOTION PASSED.

Marilyn reported that on the one 2014/2015 delinquent assessment, that a consent judgment was entered and now a lien needs to be filed. Mike Steeno stated that on the consent judgment there is a provision for a special lien and it puts the legal description on the special lien. Mike announced that he would call the attorney to see what procedure she follows. Mike stated that he would call the defendant to see if he would like to make payment arrangements for the delinquent assessment.

Marilyn reported that during the construction of the Droege's new home, a sewer cleanout was damaged, so it was turned in to the insurance for the sewer board. A payment of \$1,162.00, from the insurance company, was written to the LTPOA, so Marilyn

stated that she would deposit it and write a check to the sewer district for that amount.

Building

Doug Leeker reported that there were no new applications. Doug asked what to do with the applications after approval and Steve announced that the applications should be filed in the sales office.

Security

Roy Hummel reported that the 4th of July went well. Roy reported that the buoys on the lake helped keep the boats from getting close to the dam. He stated that the guard spent his time making trips around the lake and at the dam. One mailbox was knocked down near the gate and it has been repaired. Steve thanked the LTIA for all their work in informing residents of the new rules for the 4th.

Gate

Rich Hirsch reported that there was nothing new to report.

Maintenance

Doug Leeker reported that he spoke to Ameren about picking up the utility poles on the north and south sides that had fallen due to trees.

Steve reported that the leak in the sales office at the chimney looks bigger than he first thought. He suggested capping the chimney off.

Steve stated that John Dauernheim has marked some areas in red on the south side road and he is interested in getting a bid from CEG Paving and others willing to give us a bid on repairing the road. Dam

Clarue Holland was not present, but sent a letter to the board and Doug Leeker summarized by stating that Clarue wants us to look at the seepage again. Doug suggested that we let the dam area dry out from all of the rain and after this time take another look at the seepage.

Old Business

President Blaha asked if anyone had any old business to report. Gerald Arbini (A-40) spoke about the water willow. He reported that he has spent hundreds of dollars trying to rid his lakefront area of the water willow. He asked for suggestions on how to rid the area of water willow. President Blaha reported that he would contact Kevin Scheirich, with the fishing association and show him the pictures of the water willow that is on Mr. Arbini's shoreline. Doug Leeker reported that he has used the herbicide Habitat and it worked well on his water willow. Janet Hirsch suggested that the Tishomingo Anglers Association should be notified before the budget meeting, to let them know that they should take care of the water willow before the LTPOA decides on their request for money for next year. Steve suggested that when the lake is lowered in the fall of 2016, this might be a good time to take care of the water willow.

New Business

Jan Hunnicutt reported that she had a complaint about the number of pontoons tied together in a cove. She stated that they tie up and swim to the shore and it makes it difficult to get in or out of the cove. She would like to have a rule on how many boats can tie up together. LTPOA Meeting Minutes August 11, 2015

Board Members Present: Steve Blaha, Mike Steeno, Marilyn Meyer, Doug Leeker, Ken Stojeba and Shelby Reneski.

President Blaha called the meeting to order at 7:06p.m. There were six residents in attendance and all recited the Pledge of Allegiance.

President's Report

President Blaha thanked everyone for attending the meeting tonight.

President Blaha asked the board members if they had read last month's minutes and if they had any additions, corrections or deletions. With nothing new to correct or add, President Blaha asked for a motion to dispense with the reading of the minutes and approve them as printed. Marilyn made a motion to waive the reading and approve the minutes and it was seconded by Ken. MOTION PASSED.

Treasurer's Report

Marilyn Meyer reported on the financial report for July 2015. Please see the attachment. Ken Stojeba asked how much more in assessments we are expecting and Marilyn reported that we have about \$110,000 still to be paid. Ken made a motion to accept the financial report and it was seconded by Doug. MOTION PASSED.

Marilyn asked for approval to pay bills totaling \$3,546.50. This includes an insurance refund to PWSD #13, which was inadvertently written to the LTPOA instead of PWSD #13 for \$1,162.00, Dale Wallen for cutting the common areas five times (\$650.00), Mike Steeno for the annual registration for Missouri (\$11.25), Mickey K's for the portable toilet rental (\$90), lien release on 6213 South Lakeshore Drive for paying their assessment (\$24.50), GCI Security (\$1,532.04), wine for the welcome baskets (\$46.37) and

year. Ken made a motion to approve the proposed budget and it was seconded by Marilyn. MOTION PASSED.

Janet Hirsch stated that the newsletter deadline is August 20th.

Parents Club and Garden Club

Sewer

Rich Hirsch reported no new business.

Water Testing

Clarue Holland was not present, so Marilyn Meyer reported that Clarue collected lake water samples, on August 10th from the same 15 sites, at a cost of \$31.00 per site.

Dam

Marilyn also reported that Clarue is urging us to make the collection ponds and she offered to help fill sand bags. Marilyn stated that Clarue has spoken with the water-testing lab and they can test and be confident of where the seepage is coming from. While the increase in the seepage may be nothing at all, Clarue has been asked numerous times by the engineers from the MO Department of Natural Resources to call them should there be any increase. Marilyn stated that Clarue has purposely held off calling until she could tell them of definite plans for the monitoring. This increase just might be the beginning of a major leak and that does scare Clarue. Wasting time is not Clarue's way of doing things, especially something to do with our most important asset, the lake.

Ken Stojeba reported that he has hired someone to relocate the groundhogs.

President Blaha stated that we would caucus after the meet-

ing to decide how to proceed with the collection ponds for the seepage.

Old Business

President Blaha reported that we have been looking into a solution to keep the water from coming over the road during storms. He stated that we have looked at several ideas. One idea was a swale and another was an additional two tubes under the road. The latest was a new bridge that would span across that area. He stated we are still reviewing the options. Steve reported that Rich Hirsch has been involved with all three meetings and has put together a pro and con list on each solution. Rich Hirsch stated that the problem we have now with the bridge is there are two tubes and the two tubes tend to get plugged from the debris coming down the creek during storms and when they are blocked, the water goes over the road. Rich Hirsch spoke on the preliminary cost estimate letter from 1993 and the current bridge. Rich stated that the current solution would be to build a clear span with two supports. He stated that there are a number of reasons why this would be advantageous, but the problem is it would cost from \$150,000 to \$200,000. This project would take about two months to complete. One way to reduce the cost would be if the bridge did not have to support any traffic during the construction. It would be less expensive to build a bridge plus an access road from the south side to Highway BB, than to build a bridge and support traffic during construction. There was discussion on where this access road would be located. Rich discussed the pro and cons of building a new bridge and there was discussion on the solutions.

Janet Hirsch suggested a gauge stick to measure the depth of water when it is covering the road. President Blaha suggested a gauge to see how high the water gets, but stated that we would

Proper Use of the System

To keep your system operating properly be careful about what you allow to go down the drain.

Do not use the garbage disposal excessively. Food by-products accelerate the need for septage pumping and increase maintenance. Collect grease in a container and dispose with your trash. Use paper towels to wipe pots and pans to soak up excess grease before washing. Compost table scraps or dispose with your trash.

Do use your trash can to dispose of substances that can clog filters, cause maintenance problems, and increase the need for septage pumping.

Do not put any of the following items into the system:

- Egg shells, large seeds, gum, coffee grounds
- Tea bags, chewing tobacco, cigarette butts
- Condoms, dental floss, sanitary napkins, tampons, diapers
- Paper towels, newspapers, candy wrappers
- Rags, large amounts of hair
- "Flushable" wipes, baby wipes, medicated wipes, cleaning wipes
